THE COVENANTS, CONDITIONS AND PROVISIONS PROVISED FOR VIOLELY REPURDED TO ARE:

- 1. Promises of Borrower -- Borrower represents and warrants that:
 - a. Borrower owns the Property:

If Trustee forecloses this Trust Deed on behalf of the Holder of the Note, snyone who buys the Property at the foreclosure sale will have all the rights under the insurance policy.

- 5. Borrower's Promise to Buy Flood Insurance. If the Land or my part of the Land is located in a designated official flood-hazard area, Borrower promises to buy flood insurance in the maximum amount available or the amount secured by this Trust Deed, whichever is less. Borrower agrees to direct that any money payable under the fixed insurance will be paid to Trustee on behalf of the Holder of the Note, but Borrower will still have to make regular payments under the Agreement until the entire amount Borrower owes is paid in full.
- 6. Borrower's Promise to Maintain and Repair the Property. Any hazard insurance and/or flood insurance purchased by the Trustee or Holder of the Note on the Property may be limited to the amount due under the Agreement at the time the insurance is purchased, even if the Property is worth more. The Trustee or the Holder of the Note is not required to obtain the lowest cost insurance that might be available.

- S. Rights of the Trustee and Holder of the Nove. Any failure or delay by the Trustee or the Holder of the Note in enforcing the rights available to them in this Trust Deed to the law, will not cause the Trustee or Holder of the Note to give up those rights. The Trustee or Holder of the Note may exercise and enforce any of its rights until its rights under the Trust Deed and. Each right that this Trust Deed gives to the Trustee or toe Holder of the Note is separate. The Trustee or Holder of the Note may enforce and exercise them one at a time or all at a very
- 9. Joint Borrowers. Each person that signs this Trust Deed is responsible for keeping all of the promises made by the Romower. Trustee or Holder of the Note may choose to enforce their rights against anyone signing the Trust Deed as an individual or against all of them. However, if someone signed this Trust Deed, out did not sign the Agreement, then that person will not be required to pay any amount under the Agreement, but will have signed only to give Trustee or Holder of the Note the rights that person has in the Property under the same of this Trust Deed.

- 13. No Other Mortgages or Deed of Trust. Borrower agrees not to mortgage or encumber by a deed of trust all or any part of the Property or allow anyone cise to have a list on the Property without the Holder of the Note's written consent.

14. Trustee/Holder of the Note - Je necies and For closure.
