SPECIAL AMENDMENT NO. 4 TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS AND COVENANTS FOR RIVER POINTE CONDOMINIUM

THIS SPECIAL AMENDMENT NO. 4 TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS AND COVENANTS FOR RIVER POINTE CONDOMINIUM is made and entered into by RIVER DEVELOPMENT, L.L.C. ("Declarar")

RECITALS:

- A. Declarant Recorded the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for River Pointe Condominium (the "Declaration") on February 26, 1997 in the Office of the Recorder of Deeds for Cook County, Illinois ("Office"), as Document No. 97131342.
- B. Declarant Recorded Special Amendment No. 1 to the Declaration on May 9, 1997 in the Office as Document No. 97326822 ("Special Amendment No. 1").
- C. Declarant Recorded Special Amendmen, No. 2 to the Declaration in the Office on May 22, 1997 as Document No. 97363289 ("Special Amendment No. 2").
- D. Declarant Recorded Special Amendment No. 3 to the Declaration in the Office on July 14, 1997 as Document No. 97503252. The Declaration, as amended by Special Amendment No. 1. Special Amendment No. 2, and Special Amendment No. 3, is herein called the "Condominium Declaration". The Condominium Declaration subjected the Property legally described on Exhibit A attached hereto and made a part hereof to the Condominium Declaration and submitted it to the provisions of the Act.
- E. Declarant is the owner of Parking Spaces P1-49 and P1-1 which were subjected to the Condominium Declaration and submitted to the provisions of the Act pursuant to the Condominium Declaration. In accordance with Section 26 of the Act. Declarant desires to transfer and assign Parking Space P1-49 to Dwelling Unit No. 1-804 and to transfer and assign Parking Space P1-1 to Dwelling Unit No. 1-701 by Recording this Special Amendment.
 - F. Parking Spaces P1-49 and P1-1 were not previously assigned to any Dwelling Unit.
- G. The undivided interests in the Dwelling Units are unaffected by the transfers described in Recital E above and they shall remain the same as set forth in the Condominium Declaration.

NOW THEREFORE. Declarant does hereby amend the Declaration as follows:

1. All terms used herein, if not otherwise defined herein, shall have the meanings set forth in the Declaration.

- 2. The Plat of Survey attached as Exhibit C to the Condominium Declaration is hereby amended, as shown on Exhibit Z attached hereto, to identify Parking Space P1-49 as an additional parking space which is assigned to Dwelling Unit No. 1-804 and to identify Parking Space P1-1 as an additional parking space assigned to Dwelling Unit 1-701.
- Exhibit D to the Condominium Declaration is hereby amended to provide that Parking Space P1-3. 49 is assigned to Dwelling Unit No. 1-804 and Parking Space P1-1 is assigned to Dwelling Unit No. 1-701.
 - 4. Except as herein amended, the Declaration shall continue in full force and effect.
- The undersigned hereby certify that a copy of Special Amendment No. 4 has been delivered to 5. the Board of Managers of River Pointe Condominium Association.


