WHEREAS, the Property is located in Chicago, Illinois and is bounded on the north by 16th Street, the east by Canal Street, the south by 18th Street and the west by Clinton Street (the "Boundaries");

WHEREAS, pursuant to the certain documents ("Documents") recorded with the Cook County, Illinois Recorder's Office as Document Numbers 13035228, 13077691, 13080254, 13093889, 13006358, 13227685, 13393351, 13997755, 14009053, 14009055, 14009063, 14030702, 14045188, 14522243, 15600199, 18163021, 18178877 and 18187503 easements ("Railroad Easements") were created for the use, in common with the owners of the Property, and maintenance of all railroad tracks, switches and spur tracks then or thereinafter constructed within the Boundaries; and
