1. Payment of Principal, Interest and Late Charge. Borrower shall pay when due the principal of, and

2. Monthly Payment of Caxes, Insurance and Other Charges. 4. Fire, Flood and Other Hazard Insurance. NON-UNIFORM COVENANTS. Borrower and Lender further covenant and agree as follows:

17. Assignment of Rents. Borrower unconditionally assigns and transfers to Lender all the rents and revenues of the Property.
