(C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding TWO AND 875 / 1000 percentage points (to the Current Index. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.125%).
