Bonower covenants that Bonower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the I roperty, and that the Property is unencumbered, except for encumbrances of record. Bonower covenants that Bonower warrants and will defend generally the title to the Property against all claims and demands, subject to encumbrances of record.

UNIFORM COVENANTS, Borrower and Lender covenant and agree as follows:

- 1. Payment of Principal and Interest at Variable Rates. This mortgage secures all payments of principal and interest due on a variable rate loan. The contract rate of interest and payment amounts may be subject to change as provided in the Note. Borrowers shall promptly pay when due all amounts required by the Note.
- 2. Funds for Taxes and Erzurance. Subject to applicable law or waiver by Lender, Borrower shall pay to Lender on the day mornthly payments of principal and interest are payable under the Note, until the Note is paid in full, a sum (herein 'Funds') equal to one-twelfth or the yearly taxes and assessments (including condominium and planned unit development assessments, if any) which may attain priority over this Mortgage and ground rents on the Property. If any, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof. Borrower shall not be obligated to make such payments of Funds to Lender to the extent that Borrower makes such payments to the holder of a prior mortgage or deed of trust if such holder is an institutional lender.

Any fotbearance by Lender in exercising any right or remedy hereunder, or otherwise afforded by applicable law, shall not be a waiver of or preclude the exercise of any such right or remedy.
