SECOND EXTENSION AND MODIFICATION AGREEMENT

THIS SECOND EXTENSION AND MODIFICATION AGREEMENT, made this 29th day of September, 1997 by and between AMALGA MATED BANK OF CHICAGO, an Illinois banking corporation ("Lender"), and John G. Rooney and Margaret A. Kroney, his wife ("Borrower"),:

Recitals

- A. Borrower executed and delivered a promissory entertailed January 29, 1993, payable to Lender in the original principal amount of \$230,000.00 (the "Note")
