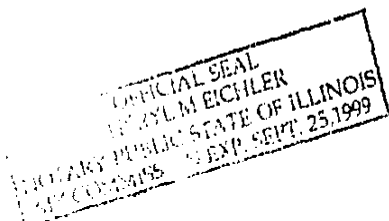

**10.
