FIRST AMENDMENT TO LOAN DOCUMENTS

This First Amendment to Loan Documents ("First Amendment"), 13 made this 7TH day of September 1997, by ARUNKUMAR P. PATEL, MADHU A. PATEL ("collectivley Borrower"); AND FIRST EAGLE NATIONAL BANK, a national banking association ("Lender").

A. On MARCH 7,1997, Lender made a Nondisclosable Non-revolving Line of Credit (the "Loan") to Borrower in the amount of TWO HUNDRED NINETY TWO THOUSAND THREE HUNDRED dollars (\$292,300.00). The Loan was evidenced by the note ("Note") of Borrower, dated MARCH 7,1997 in the principal amount of TWO HUNDRED NINETY TWO THOUSAND THREE HUNDRED dollars (\$292,300.00).

- B.
