CLAIM FOR LIEN

Carpet Styles Co., Inc. ("Claimant") hereby files a claim for lien and in support thereof states as follows:

1. On August 4, 1997, Claimant entered into a contract with Woodfield Gardens Associates whereby Claimant agreed to furnish all labor and material for the installation of carpeting on the property commonly known as 4728 Arbor Drive, Rolling Meadows, Illinois 60008, which property is more particularly described on Exhibit 1 attached hereto (the "Property") for the price of \$1,010.07.

2. At the time of the making of said contract, LaSalle National Bank as Trustee under a Trust Agreement dated August 3, 1983 and known as Trust No. 106823 was the record title holder of the Property; and Woodfield Gardens Associates was the owner of the Property or was authorized or knowingly permitted by the owner to enter into said contract.

3. On August 6, 1997, Claimant completed all required of it to be done pursuant to its contract.

4. Nothing has been paid on the contract; and after allowing all credits there remains a balance due and owing to Claimant of \$1,010.07, for which amount, plus interest, Claimant claims a lien on the Property.


