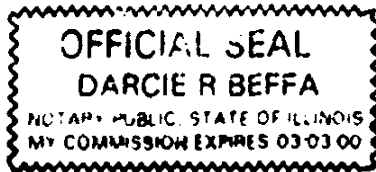

LEGAL ADDENDUM "A"

THAT PORTION OF LOT 3 IN THE SUBDIVISION OF (EXCEPT THE EAST 770 FEET THEREOF) THAT PORTION LYING NORTH OF THE SOUTH 20 ACRES OF THAT PART LYING EAST OF THE CENTER OF RIEGLE ROAD (AS SAID ROAD WAS HERETOFORE LAID OUT BY THE HIGHWAY COMMISSIONERS OF BLOOM TOWNSHIP) OF THE NORTH 1/2 OF THE NORTHWEST 1/4 OF SECTION 5, TOWNSHIP 35 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED JULY 9, 1922 AS DOCUMENT NUMBER 75 67 488, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE SOUTH LINE OF LOT 3, 172 FEET EAST OF THE INTERSECTION OF SAID SOUTH LINE WITH THE CENTER LINE OF RIEGLE ROAD (WHICH POINT OF INTERSECTION IS THE SOUTHWEST CORNER OF SAID LOT 3) THENCE RUNNING EAST ALONG THE SOUTH LINE OF SAID LOT 3, A DISTANCE OF 128 FEET, THENCE RUNNING NORTH PARALLEL TO THE EAST LINE OF SAID LOT 3, A DISTANCE OF 81 FEET; THENCE RUNNING WEST PARALLEL TO THE SOUTH LINE OF SAID LOT 3, A DISTANCE OF 128 FEET; THENCE RUNNING SOUTH PARALLEL TO THE EAST LINE OF SAID LOT 3, A DISTANCE OF 81 FEET TO THE POINT OF BEGINNING, IN COOK COUNTY, ILLINOIS.
