### FLEXEQUITY ACCOUNT MORTGAGE

THIS FLEXEQUITY MORTGAGE is made this 25th day of October 1997 by and between Jason Scott Hidy and Kathleen M. Hidy, Husband and Wife

(herein "Borrower") and GLENVIEW STATE BANK, an Illinois Corporation, whose address is 800 Waukegan Road, Glenview, Illinois 60025 (herein "Lender").

Whereas, Borrower is indebted to Lender under that certain FlexEquity Account Promissory Note dated October 25, 1997 (herein "Note") with a credit limit of Ten Thousand Dollars and no/100 dollars (\$ 10,000.00) (a minimum amount of \$10,000.00) of which an initial advance of xxxxxxxxxxxxxxxxxxxxxxxx (\$ xxx ) has been made and against which Borrower may draw and Lender is obligated to make advances from time to time to the full amount thereof. Repayments of sums advanced from time to time will replenish the credit limit pro tanto so that the total amount that may be lent under the Note may exceed the credit limit thereof but not at any one time. The Note provides for monthly installments of interest or, if Borrower has elected to take any advance as a term loan, of principal and interest, at the rates set forth in the Note, with the principal balance of the indebtedness, if not sooner paid or required to be paid, due and payable five (5) years from the date hereof.

Borrower, in consideration of the indebtedness herein recited, does hereby mortgage, grant, warrant and convey (unless Borrower is a Trust, in which event Borrower does hereby mortgage, grant, warrant and convey) unto Lender and its successors and assigns, the following described property located in the County of Cook, State of Illinois:

2. FUNDS FOR TAXES AND INSURANCE. Subject to applicable law or to a waiver by Lender, Borrower shall pay to Lender on the day monthly installments of interest would be payable under the Note, until the Note is paid in full, a sum (herein "Funds") equal to one-twelfth of the yearly taxes and assessments which may attain priority over property, and ground rents on the property if any, plus one-twelfth of yearly premium installments for hazard

1. PAYMENT AND COMPLIANCE WITH NOTE; APPLICABILITY OF PAYMENTS. Borrower shall promptly pay other charges imposed under the Note, and the principal and interest on any future Advances (as defined in Paragraph 27 below) secured by this Mortgage. Unless applicable law requires otherwise, all payments received under the Note and this Mortgage shall be applied by Lender first to Payment of any additional sums owing to Lender pursuant to the provisions of the Credit Documents, whether as advances, attorney's fees (to the extent permitted by law) delinquencies, costs and expenses of exercising rights and remedies granted under the Credit Documents; second, to the payment of any sums due under Paragraph 2 hereof; third, to the payment of interest on the Note; fourth, to the payment of principal of the Note; and then to interest and principal on any Future Advances.

**Covenants, Bottower and Lender covenants and agree as follows:**

**THIS MORTGAGE IS GIVEN TO SECURE:** (i) the repayment, of the indebtedness evidenced by the Note; (ii) the payment of all other sums, which interest thereon, advanced in account, and herewith to protect the security of this Mortgage; and (iii) the performance of the covenants and agreements of Borrower contained herein and in the Note, and, if in title to the property is held by a Trust, in the FlexEquity Security Agreement ("Security Agreement") of even date herewith. The Note, the Security Agreement, this Mortgage and any and all instruments now or hereafter given to secure the indebtedness evidenced by the Note are collectively referred to herein as the "Credit Documents". The Credit Documents contemplate and this Mortgage permits and enables, future advances.

Borrower acknowledges that the Note calls for a variable interest rate, and that the Lender may, prior to the expiration of the term of the Note, cancel future advances therunder, reduce the amount of credit available, and/or require repayment of the outstanding balance under the Note.

Borrower covenants that Borrower is the lawful owner of the cattle in said heretby conveyed and has the right to grant, convey and mortgage the property, and that the Property is unencumbered except for the certain Mortgage or Deed of Trust in favor of First Federal Bank for \$46, dated September 30, 1996 and recorded/re-registered October 3, 1996 as Document No. 96-756456 in the Office of the Recorder of Deeds/Register of Titles, Cook County Illinois. insurance, plus one-twelfth of yearly premium installments for mortgage insurance, if any, all as reasonably estimated initially and from time to time by Lender on the basis of assessments and bills and reasonable estimates thereof.

The funds shall be held in an institution the deposits or accounts of which are insured or guaranteed by a Federal or State Agency (including Lender if Lender is such an institution). Lender shall apply the Funds to pay said taxes, assessments, insurance premiums and ground rents. Lender may not charge for so holding and applying the Funds, analyzing said account or verifying and compiling said assessments and bills, unless Lender pays Borrower interest on the Funds and applicable law permits Lender to make such a charge. Borrower and Lender may agree in writing at the time of execution of the language that interest on the Funds shall be paid to Borrower, and unless such agreement be made or applicable law requires such interest to be paid, Lender shall not be required to pay Borrower any interest or earnings on the Funds. Lender shall give to Borrower, without charge, an annual accounting of the Funds showing credits and debits to the Funds and the purpose for which each debit to the Funds was made. If the amount of the Funds held by Lender, together with the future monthly installments of Funds payable prior to the due dates of taxes, assessments, insurance premiums and ground rents, shall exceed the amount required to pay said taxes, assessments, insurance premiums and ground rents as they fall due, such excess shall be, at Borrower's option, either promptly repaid to Borrower or credited to Borrower on subsequent monthly installments of Funds. If the amount of Funds held by Lender shall not be sufficient to pay taxes, assessments, insurance premiums and ground rents as they fall due, Borrower shall pay to Lender any amount necessary to make up the deficiency within thirty (30) days from the date notice is mailed by Lender to Borrower requesting payment thereof.

Neither Lender nor any institution designated by Lender to hold the Funds shall be liable for any failure to make the payments of insurance premiums, taxes or ground rents unless Borrower, while not in default hereunder, shall have requested Lender or such institution to make application of the Funds to the payment of the applicable insurance premiums, taxes or ground rents, accompanied by the bills for such insurance premiums, taxes or ground rents. Notwithstanding the foregoing Lender may, at its option, make or cause such institution to make any such application of the Funds without any direction or request to do so by Borrower.

Upon payment in full of all sums secured by this Mortgage, Lender shall promptly refund to Borrower any funds held by Lender. If under Paragraph 17 hereof the Property is sold or the Property is otherwise acquired by Lender, Lender shall apply, no later than immediately prior to the sale of the Property or its acquisition by Lender, any Funds held by Lender at the time of application as a credit against the sums secured by this Mortgage.

**3. PRIOR ENCUMBRANCE; CHARGES; LIENS.** Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payment when due. A default under any prior mortgage or deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage may at the option of Lender be declared and deemed to be a default under this Mortgage but only if such default adversely affect Lender's security for the note of any rights of Lender in the security. Borrower shall pay all taxes, assessments and other charges, fines and impositions attributable to the Property which may attain a priority over this Mortgage, and leasehold payments or ground rents, if any, in the manner provided under Paragraph 2 hereof or, if not paid in such manner, by Borrower making payment, when due, directly to the payee thereof. Borrower shall promptly furnish to Lender all notices of amounts due under this paragraph, and in the event Borrower shall make payment directly, Borrower shall promptly furnish to Lender receipts evidencing such payments. Borrower shall promptly discharge any lien which may attain priority over this Mortgage (other than any prior first mortgage or deed of trust); provided, that Borrower shall not be required to discharge any such lien so long as Borrower shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Lender or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings which operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.

**4. HAZARD INSURANCE.** Borrower shall, at Borrower's cost keep the improvements now existing or hereafter erected on the Property insured against loss by fires, hazards included within the term "extended coverage and such other hazards (collectively agreed to as "Hazards" as Lender may require. Borrower shall maintain Hazard insurance for the entire term of the Note or such other periods as Lender may require and in an amount equal to the lesser of (a) the maximum insurable value of the Property or (b) the amount of the line of credit secured by this Mortgage plus the outstanding amount of any obligations secured in priority over this Mortgage, but in no event shall such amounts be less than the amount necessary to satisfy the co-insurance requirement contained in the insurance policy.

6. **PROTECTION OF LENDER'S SECURITY.** If Borrower fails to perform the covenants and agreements contained in the Master Agreement or in the Credit Documents, or if any action or proceeding is commenced without Lender's interest in the property or the rights of powers of Lender hereunder, including but not limited to eminent domain, insolvency, code enforcement or attorney fees involving a bankruptcy or decree, without demand upon Borrower but upon notice to Borrower pursuant to Paragraph 11 hereof, may, without releasing Lender's interest in the property or the rights of powers of Lender hereunder, including but not limited to eminent domain, insolvency, code enforcement or attorney fees involving a bankruptcy or decree, Lender shall pay the premiums required to maintain such insurance in effect until such time as the requirements for Borrower shall pay the premiums required to maintain such insurance in effect until such time as the requirements for such insurance terminates in accordance with Borrower's and Lender's agreement of applicable law.

PROPRIETLY COMPILY WITH THE PROVISIONS OF ANY LEASE IF THIS MORTGAGE IS ON A LEASEHOLD, IF THIS MORTGAGE

All insurance policies and renewals thereto shall be in a form acceptable to Lender. Lender shall have the right to hold the policies and renewals thereto, subject to the terms of any mortgage. Any amounts disbursed by Lender pursuant to this Paragraph 6, with interest thereon at the rate from time to time in effect under the Note for revolving credit advances, shall become additional indebtedness of Borrower secured by this Mortgage. Unless Borrower and Lender agree, in writing, to other terms of payment such amounts shall be payable upon notice from Lender to Borrower requesting payment therefor and if such are not paid within the time period set forth in such notice, such amounts may be charged by Lender as a draw on the Note. Nothing contained in this Paragraph 6 shall require Lender to incur any expense or take any action hereunder and any action taken shall not release Borrower from any obligation in this Mortgage.

7. **INSPECTION.** Lender may make or cause to be made reasonable entries upon and inspections of the Property, provided that, except in an emergency, Lender shall give Borrower notice prior to any such inspection specifying reasonable cause therefor related to Lender's interest in the Property.

8. **CONDEMNATION.** The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation, are hereby assigned and shall be paid to Lender subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has priority over this Mortgage. Borrower agrees to execute such further documents as may be required by the condemnation authority, to effectuate this paragraph. In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Borrower. In the event of a partial taking of the Property, unless Borrower and Lender otherwise agree in writing, there shall be applied to the sums secured by this Mortgage such proportion of the proceeds as is equal to that proportion which the amount of the sums secured by this Mortgage immediately prior to the date of taking bears to the fair market value of the Property immediately prior to the date of taking, with the balance of the proceeds paid to Borrower.

Lender shall not be required to commence proceedings against such successor or refuse to extend time for payment or otherwise modify payment terms of the sums secured by this Mortgage by reason of any demand made by the original Borrower and Borrower's successors in interest. Lender shall not be deemed, by any act of omission or commission, to have waived any of its rights or remedies hereunder unless such waiver is in writing and signed by Lender. Any such waiver shall apply only to the extent specifically set forth in the writing. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event. The procurement of insurance or the payment of taxes, other liens or charges by Lender shall not be a waiver of Lender's right as otherwise provided in this Mortgage to accelerate the maturity of the indebtedness secured by this Mortgage in the event of Borrower's default under this Mortgage or the other Credit Documents.

All of the terms, covenants, conditions, and agreements set forth herein shall be binding upon and terms to the benefit of such parties except that no right shall inure to any successor of Borrower unless consumed to by Lender as herein provided. B. Set forth below is a list of events which, upon the lapse of the applicable grace period, if any, shown particularly after such event, will constitute an Event of Default: (1) Borrower's failure to pay when due any amounts due under the Credit Documents (30 day grace period); (2) Borrower's receipt of actual knowledge of any fraud or misrepresentation by Borrower in connection with the line of credit, whether committed in or omitted from Borrower's credit application or committed during the term of the Note (no grace period); (3) Borrower's default of material terms and the transfer of Borrower's interest in the Property of the Collateral (as such term is defined in the Security Agreement) to someone who is a signer of all the Credit Documents, if any, and, as a result thereof, Lender's security for the Note or any rights of the Lender in such security are adversely affected (no grace period); (4) Borrower's sale of transfer of, or promise to sell or transfer, all or any part of the Property or any interest therein, of any interest in the Collateral, whether voluntary or involuntary, without Lender's prior written consent (no grace period); (5)

A. An Event of Default will occur if Lender gives written notice of the breach of any of the Credit Documents and upon Borrower's failure to cure such breach and to provide Lender with a adequate reasonably satisfactory documentation or credit report under the terms of the Credit Agreement, and upon the application of the grace period, if any, after notice given by Lender to Borrower, Lender may declare all of the obligations of Borrower under the Credit Agreement to be due and payable at 1:59 p.m., Central time, on the last day of the period. 14. REMEDIES CUMULATIVE. Lender may exercise all or some of the rights and remedies provided in this Mortgage and in the Credit Documentation, of which may be available to Lender by law, and all such rights and remedies shall be cumulative and concurrent, and may be pursued singly, severally or together, at Lender's sole discretion, and may be exercised as often as occasion therefor shall occur.

12. GOVERNING LAW: SEVERABILITY. This Mortgage shall be governed by the laws of the State of Illinois, which laws shall also govern the construction, enforcement and interpretation of this Mortgage. The foregoing sentence shall not limit the applicability of federal law to this Mortgage. Every provision hereof is intended to be severable. In any clause, paragraph, section or portion of this Mortgage or the application thereof is determined by a court of competent jurisdiction to be void, all of the remaining parts under applicable law, the remaining clauses, paragraphs and portions of this Mortgage; they will be affected or impacted thereby, but each such remaining clause, paragraph, provision and portion shall be valid and permissible by law.

13. BORROWER'S COPY. Borrower shall be furnished a conforming copy of the Note and of this Mortgage at the time of execution or after recordation hereof.



