THAT at the special instance and request of said Contractor and Owner the Claimant furnished extra and additional materials at and extra and additional labor on said premises in the amount of FOUR HUNDRED NINETY SIX "HOUSAND SIX HUNDRED FIFTY FIVE AND 00/100 DOLLARS (\$496,655.00) and completed some on August 1, 1997.

THAT said Contractor is entitled to credits on account thereof in the amount of SIX HUNDRED THIRTY THOUSAND AND 00/100 DOLLARS (\$630,000,00), leaving due, unpaid and owing to the Claimant on account thereof, after allowing all credits, the sum of ONE HUNDRED SEVEN THOUSAND THREE HUNDRED FORTY SIX AND 90/100 DOLLARS (\$107,346.00), including finance charges in the amount of FOURTEEN THOUSAND SEVEN HUNDRED TWENTY EIGHT AND 00/100 DOLLARS (\$14,728.00) through September 30, 1997, for which the Claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the Owner under said contract against said Contractor and Owner.
