THIS MORTGAGE ("Security Instrument") is given on November 11, 1997.
The mortgagor is Lynette D. Watkins-Stanford, Unmarried,
whose address is 3608 Peach Grove Lane, Hazelcrest, IL 60429 ("Borrower").
This Security Instrument is given to Superior Bank FSB, which is organized and existing under the laws of
the United States of America, and whose address is 5600 North River Road,
Suite 600, Rosemont, IL 60018 ("Lender").
Borrower owes Lender the principal sum of Twelve Thousand Five Hundred and 00/100
Dollars (U.S. \$ 12,500.00). This debt is evidenced by Borrower's note dated the same
date as this Security Instrument ("Note"), which provides for monthly payments with the full debt, if not
paid earlier, due and payable on November 17, 2017. This Security Instrument secures

All insurance policies and renewals must be acceptable to Lender and must include a standard mortgage clause in favor of and in a form acceptable to Lender. Lender shall have the right to hold the policies and renewals. If Lender requires, Borrower shall promptly give to Lender all receipts of paid premiums now or hereafter received on the property, and all

2. Application of Payments. Unless applicable law provides otherwise, Lender will apply each of Borrower's payments under the Note first to accrued and unpaid interest under the Note to the date of payment and the remainder of the principal balance under the Note. Any late payment or failure to pay all taxes, assessments, charges, fines and expenses and interest on the unpaid principal balance under the Note to the date of payment and the remainder of ground rents, if any, Borrower shall furnish to Lender all notices of amounts to be paid under this paragraph, and receipts evidencing such payment.

1. Payment of Principal, Interest and Other Charges. Subject to paragraph 10, Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any late payment or failure to pay all taxes, assessments, charges, fines and expenses and interest on the unpaid principal balance under the Note to the date of payment and the remainder of ground rents, if any, Borrower shall furnish to Lender all notices of amounts to be paid under this paragraph, and receipts evidencing such payment.

BORROWER COVENANTS that Borrower is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant and convey the Property as general encumbrances of record. The encumbrances of record, Borrower warrants and will defend generally the title to the Property against all claims and demands subject to any encumbrances of record.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damaged, if the restoration or repair is economically feasible and Lender's security is not lessened. If the restoration or repair is not economically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Security Instrument, whether or not then due, with any excess paid to Borrower. If Borrower abandons the Property, or does not answer within 30 days a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may collect the insurance proceeds. Lender may use the proceeds to repair or restore the Property or to pay sums secured by this Security Instrument, whether or not then due. The 30-day period will begin when the notice is given.

Unless Lender and Borrower otherwise agree in writing, any application of proceeds to principal shall not extend or postpone the due date of the monthly payments referred to in paragraph 1 or change the amount of the payments. In that regard, Borrower shall be in default if any forfeiture action or proceeding, whether civil or criminal, is begun that in Lender's good faith judgment could result in forfeiture of the Property or otherwise materially impair the lien created by this Security Instrument or Lender's security interest. 15. Sale of Note; Change of Loan Servicer. The Note or a partial interest in the Note (together with this Security Instrument) may be sold one or more times without prior notice to Borrower. A sale may result in a change in the entity (known as the "Loan Servicer") that collects monthly payments due under the Note and this Security Instrument. There also may be one or more changes of the Loan Servicer unrelated to a sale of the Note. If there is a change of the Loan Servicer, Borrower will be given written notice of the change in accordance with paragraph 12 and applicable law. The notice will state the name and address of the new Loan Servicer and the address to which payments should be made. The notice will also contain any other information required by applicable law.

16. Hazardous Substances. Borrower shall not cause or permit the presence, use, disposal, storage, or release of any Hazardous Substances on or in the Property. Borrower shall not do, nor allow anyone else to do, anything affecting the Property that is in violation of any Environmental Law. The preceding two sentences shall not apply to the presence, use, or storage on the Property of small quantities of Hazardous Substances that are generally recognized to be appropriate to normal residential uses and to maintenance of the Property.

Borrower shall promptly give Lender written notice of any investigation, claim, demand, lawsuit or other action by any governmental or regulatory agency or private party involving the Property and any Hazardous Substance or Environmental Law of which Borrower has actual knowledge. 
