I, MARILYN R. KARNER, of the City of Palos Heights, County of Cook and State of Illinois, being of sound and disposing mind, memory and understanding, do hereby make, ordain, publish and declare this to be my Last Will and Testament, hereby revoking any and all Wills which may have been by me heretofore made.

FIRST: I hereby direct my Executor, hereinafter named, to pay all of my just debts, funeral expenses and costs of administration as soon after my death as is practicable.

SECOND: I give, devise and bequeath all my estate, real, personal or mixed, of avery kind and nature whatsoever and wheresoever the same may be situated, of which I may own or have any interest in at the time of my death to my husband, JOHN F. KARNER.

THIRD: In the event my husband shall predecease me or we die in a common disaster then I give, devise and bequeath all my estate, real, personal or mixed, of every kird and nature whatsoever and wheresoever the same may be situated, of which I may die seized and possessed, or which I may own or have any interest in at the time of my death as follows:
