

SUBORDINATION OF LIEN

WHEREAS GEORGE DOUGHERTY AND MARY C. NOW THEREFORE, in consideration of the premises and of the sum of TEN DOLLARS (\$10.00) in hand paid, the said HARRIS TRUST AND SAVINGS BANK does hereby covenant and agree with the said HARRIS TRUST AND SAVINGS BANK that the lien of the Prior Mortgage shall be and remain at all times subordinate to the lien of the Superior Mortgage securing principal indebtedness not to exceed \$255,000, together with interest thereon. Provided, however, that if the principal indebtedness secured by the Superior Mortgage is ever increased above \$255,000.00, this subordination shall be null and void and of no further force and effect with respect to any principal amounts secured by the Superior Mortgage in excess of \$255,000.00.
