LENDER'S SECURITY INTEREST AND CONDITION PRECEDENT. Borrower has requested a 2. loan from Lender to be secured by a Mortgage on the Property from Grantor in favor of ŝ Lender; Lender is only willing to make the loan on condition that Creditor's security interest described in paragraph 1 be subordinated to the Mortgage to be executed in favor of Lender.

Lender's security interest will also secure, without limitation, such additional sums as Lender may advance under the provisions as to future advances, additional sums for the purpose of curing any of Borrower's defaults, interest on principal, and attorneys' fees and costs incurred by Lender in any proceedings arising out of or in connection with Lender's security interest, including proceedings to enforce or foreclose it.

- SUBORDINATION OF CREDITOR'S SECURITY INTEREST. Creditor agrees that its security interest and all of Creditor's rights thereunder shall at all times be inferior and subordinate to the Lender's security interest and Lender's rights in the Property.
- 4. PRIORITY OF SECURITY INTERESTS. The priority of the security interests belonging to Creditor and Lender in the Property will be governed by this Agreement and not by the time or order in which the security interests were created or perfected.
- 5. WAIVER OF LIMITATIONS. Creditor waives any obligation of Lendur to provide Creditor with notice of additional advances or loans, notice of default, notice of acceleration of dabt, notice of demand for payment or notice of repossession and the right of Craditor to require Lender to marshall any colleteral. In addition, Lender may take or refrain from taking any action (including, but not limited to, making additional advances or loans) with respect to Borrower, any guarantor, or any collateral without notice to or the consent of Creditor and without affecting any of Lender's rights under this Agreement.
- 8. DOCUMENTATION AND NON-INTERFERENCE. Creditor will not prevent, hinder or delay Lender from enforcing its security interest. Creditor will execute and deliver to Lender such additional documents or other Instruments as the Lender may deem necessary to carry out this Agreement.
- 7. TERMINATION. This Agreement will remain in full force and effect now and forever, despite the commencement of any federal or state bankruptcy, insolven by rucelvership, liquidation or reorganization proceeding.
- EFFECT ON BORROWER AND THIRD PARTIES. This Agreement will not affect the enforceability and priority. of Creditor's and Lender's security Interests in the Property and Hights against the Borrower, Grantor, or siny third party except as set forth herein.
 - 9. REPRESENTATIONS AND WARRANTIES. Creditor represents and warrants to Lender that:
 - a. Creditor has not assigned any of its rights or interest in the Property prior to the execution of this Agreement. Creditor shall not assigned any or its rights of interest any claim that Creditor has or may have in the Property while any indebtedness of Borrower to Lender remains unpaid without the express written consent of the Lender;

 b. Creditor has obtained all consents and approvals needed to execute and perform its obligations under this
 - Agreement;
 - c. Creditor's execution and performance of its obligations under this Apreement will not violate any court order, administrative order or ruling, or agreement binding upon Creditor in any manner; and
 - d. Creditor has conducted an independent investigation of Borrover's princes affairs and was not induced to lend money or extend other financial accommodations to Borrower or execute this Agreement by any oral or written representation by Lender.
- 10. ASSIGNMENT. Lender shall be entitled to assign its security interest and its right and remedies described in this Agreement without notice to Creditor.
- 11. SUCCESSORS AND ASSIGNS. This Agreement shall be binding upon and Inure to the coneflit of Creditor and Lender and their respective successors, assigns, trustees, receivers, administrators, personal representatives, legatives,
- 12. SEVERABILITY. If any provision of this Agreement violates the law or is unenforceable, one rest of the Agreement shall remain valid.
- 13. NOTICE. Any notice or other communication to be provided under this Agreement shall be in writing and wint to the parties at the addresses described in this Agreement or such other address as the parties may designate in writing from time to time.
