McCAUSLAND, married to each other, of Evanston, Illinois, their heirs, legal representatives and assigns, all the right, title, interest, claim or demand whatsoever they may have acquired in, through or by a certain equity sharing agreement, bearing date of August 31, 1992, and recorded in the Recorder's office of Cook County, in the State of Illinois, as document No. 92670748, to the premises therein described as follows, situated in the County of Cook, State of Illinois, to wit:
