AGREED ORDER

THIS CAUSE COMING TO BE HEARD pursuant to the petitions of Gerald C. Kalman for temporary restraining order and/or preliminary injunction and for temporary order requiring contribution toward college expenses, and the Court being fully advised in the premises;

IT IS HEREBY ORDERED as follows:

1. The parties, Lynn T. Kalman and Gerald C. Kalman, are restrained from transferring, encumbering, concealing, or otherwise disposing of any property except in the usual course of business or for the necessities of life, consistent with their prior practices, including, but not limited to, payment of the obligations of A-Abace Diamond Quality Electricians, Inc. (the "Business").
2. This injunction extends but is not limited to all bank accounts controlled by either party or by the Business and to the marital residence. The marital residence is located at 6647 Davis St., Morton Grove, Illinois 60053.
3. The parties are not enjoined from paying a workers' compensation insurance premium payment of approximately \$8,000 to Western States Insurance Company, which is deemed an obligation incurred in the usual course of the Business.

4. Within seven days from the entry of this order, the parties shall each identify to the other, through their respective attorneys, all financial accounts which they control or in which they have any interest. Such identification shall include the name of the institution in which the account is held, the account number, the name or names of the owner or owners and signatories of the account, and the last known balance of the account.

5. The parties may, at their option, record this order or a suitable abstract or derivation thereof as a *lis pendens* notice against the marital residence.

6. The petition for temporary order requiring contribution toward college expenses is voluntarily withdrawn, without prejudice.

7. This order for temporary relief shall remain in effect until further order of Court.

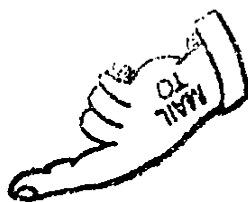
