FIRST AMENDMENT TO LOAN DOCUMENTS

The Note was secured by a Mortgage ("Mortgage"), dated OCTOBER 14, 1996 and recorded as document No. 96-810641 with the Recorder of Deeds, Cook County, Illinois ("The Recorder"); which created a FIRST lien on the property ("Property") located at 202 N KENILWORTH, MT PROSPECT, IL which is legally described on Exhibit "A" attached hereto and made a part hereof.
- C. The Note was further secured by an Assignment of Rents ("Assignment of Rents"), dated OCTOBER 14, 1996, and recorded as Document No. 96-810642 with the Recorder of Deeds, Cook County, Illinois ("The Recorder") on the Property described in Exhibit "A" attached hereto and made a part hereof.
- D. Borrowers wish to extend the Maturity Date of the Note to APRIL 18, 1998. Lender has agreed to EXTEND THE MATURITY DATE, subject to the following covenants, agreements, representations and warranties.

NOW THEREFORE, for and in consideration of the covenants, agreements, representations and warranties set forth herein, the parties hereto agree as follows:

1. **Recitals.** The recitals set forth above shall be incorporated herein, as if set forth in their entirety.
2. **Maturity Date.** The Maturity Date of the Loan shall be extended to APRIL 18, 1998.

4. **Modification of Documents.** The Note, Mortgage, Assignment of Rents, and other Loan Documents shall be deemed to be modified to reflect the modifications and amendments set forth in paragraph D AND 2.
5. **Restatement of Representations and Warranty.** The undersigned hereby restate and reaffirm each and every representation, warranty, covenant and agreement made by them in the Note, Mortgage, and other Loan Documents.
6. **Defined Terms.** All capitalized terms which are not defined herein shall have the definitions ascribed to them in the Note, Mortgage, Assignment of Rents, and other Loan documents.
7. **Extension Fee.** In consideration of Lender's agreement to **EXTEND THE MATURITY DATE** as aforesaid, Borrowers have agreed and shall pay Lender upon Borrowers' execution hereof, an extension fee in the amount of SEVEN HUNDRED SIXTEEN AND 00/100 DOLLARS (\$716.00).
8. **Documents Unmodified.** Except as modified hereby, the Note, Mortgage, Assignment of Rents, and other Loan Documents shall remain unmodified and in full force and effect.

BORROWERS RADIFY AND CONFIRM THEIR OBLIGATIONS AND LIABILITIES UNDER THE NOTE AND OTHER LOAN DOCUMENTS. THEY ACKNOWLEDGE NO DEFENSES, CLAIMS, SETOFFS AGAINST THE ENFORCEMENT BY LENDER.

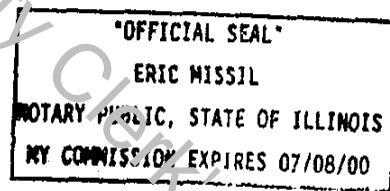

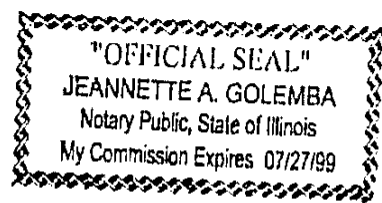
