MORTGAGE

- B. In order to provide for the payment of taxes, assessments, insurance premiums, and other charges upon the property securing this indebtedness, and other insurance required or accepted. Mortgagor promises to pay to the Mortgagoe, upon the Mortgagoe's demand, sums estimated to be sufficient to pay the aforementioned obligations up to the maximum amounts permissible by law in addition to the sums payable pursuant to the Note, which payments may, at the option of the Mortgagoe, (a) be held by it and commingled with other such funds or its own funds for the payment of such items; (b) be carried in a savings account and withdrawn by it to pay such items; or (c) be credited to the unpaid balance of said indebtedness as received. If the amount estimated to be sufficient to pay said items is not sufficient. Mortgagor promises to pay the difference upon demand. If such sums are held or carried in a savings account, or escrow account, the same are hereby pledged to further secure this indebtedness. - M. If the Note secured by this Mortgage is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the loan exceed the permitted limits, then:
