If the owners association or other entity which acts for the Condominium Project (the "Owner's Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Mortgagor's interest in the Owners Association and the uses, proceeds and identifits of Mortgagor's Interest. CONDOMINIUM COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Mortgagor and Londer further covenant and agree as follows: A. Condominium Obligations. Mortgar, shall perform all of Mortgagor's obligations under the Condominium Project's Constituent Documents. Mortgagor shall not, except after notice to Lender and with Conder's prior written consent, either partition or subdivide the Property or consent to: (i) the abandonment or termination of the Condominium Project, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty or in the case of taking by conduct listion or eminent domain; (ii) any amendment to any provision of the Constituent Documents if the provision is for the exprese benefit of Lender; (iii) termination of professional management and assumption of self-management of the Owners Association; or (Iv) any action which would have the effect of rendering the public liability insurance coverage maintained by the Owners Association unacceptable to Lender. F. Remedies. If Mortgagor does not pay condominium dues and assessments when due, then Lender may pay them. Any amounts disbursed by Lender under this paragraph F shall become additional debt of Mortgagor secured by the Security Instrument. Unless Lander agrees to other terms of payment, these amounts shall bear interest from the date of disbursement at the Note rate and shall be payable, with interest, upon notice from Lender to Mortgagor requesting payment. G. Appointment. Mortgagor irrevocably appoints Lender as proxy, with full power of substitution and revocation, for the term of the Security Instrument, upon the occurrence of any event of default to exercise Mortgagor's rights to attend meetings, vote, consent to arid/or take any action with respect to the Condominium Project, the unit, or the Owners Association as fully as Mortgagor might do. Lander has not and is not assuming any obligations of Mortgagor with respect to the Condominium Project, or the unit. Lender shall not have any liability to Mortgagor for any vote cast by Lender or for any failure by Lender to cast a vote and Mortgagor releases Lender from any such flability.
