#### EXTENSION AGREEMENT

This Indenture, made this 1st day of November, 1997, by and between Devon Bank, an Illinois Banking Corporation the owner of the trust deeds hereinafter described, and Barry Brown and Audree Brown, his wife representing himself or themselves to be the owner or owners of the real estate hereinafter and in said deed described ("Owner"),

#### WITNESSEIH:

1. The parties hereby agree to extend the time of payment of the indebtedness evidenced by the principal premissery note or notes of Barry and Audice Brown dated December 10, 1996, secured by trust deeds in the nature of several mortgages and assignment of rents recorded on January 13, 1997, in the office of the Recorder of Cook County, 11 inois as document nos. 97026792,97026797,97026793,97026798,97026794,97026799, 97026795,97026801,97026795, and 97026800, conveying to Devon Bank, an Illinois Banking Corporation certain real estate in Cook County, Illinois described as follows:

- 2. The amount remaining unpaid on he indebtedness is \$500,000.00.
- Said remaining indebtedness of \$600,000.00 shall be paid on or before December 1, 1997.

and the Owner in consideration of such extension promises and agrees to pay the principal sum secured by hald martdage or trust deed as and when therein provided, as here's extended, and to pay interest thereon until <a href="December 1, 1997">December 1, 1997</a>, at the rate of One Half (1/2%) percent per annum in excess of Prime Rate, and thereafter until maturity of said principal sum as hereby extended, at the rate of One Half (1/2%) percent per annum in excess of Prime Rate, and interest after maturity at the rate of Three ( One Half (3 1/2%) percent per annum in excess of Prime Rate, and to pay both principal and interest in the coin or currency provided for in the mortgage or trust deed hereinabove described, but it that empot be done legally then in the most valuable legal tender of the United States of America current on the due date thereof, or the equivalent in value of such legal tender in other United States currency, at such banking house or trust company in the City of Chicago as the holder or holders of the said principal note or notes may from time to time in writing appoint, and in default of such appointment then at Devon Bank, 6445 North Western Avenue, Chicago, Illinois 60645-5494.

4. If any part of said indebtedness or interest thereon be not paid at the maturity thereof as herein provided, it if default in the performance of any other covenant of the Owner shall continue for twenty days after written notice thereof, the entire principal

sum secured by said mortgages or trust deeds, together with the then accorded interest thereon, shall without notice, at the option of the holder or holders of said principal note or notes, become and be due and payable, in the same manner as if said extension had not been granted.

f. This agreement is supplementary to said mortgages and trust deeds. All the provisions thereof and of the principal note or notes, including the right to declare principal and accrued interest due for any cause specified in said mortgages or trust deeds or notes, but not including any prepayment privileges unless herein expressly provided for, shall remain in full force and effect except as herein expressly modified. The Owner agrees to perform all the covenants of the granter or granters in said mortgages and trust deeds. The provisions of this indenture shall inure to the benefit of any holder of said principal note or notes and interest notes and shall hind the heirs, personal representatives and assigns of the Owner.
