The year of 1795 Davis made another call on Cook, then a
young man of 21, at his home in New Haven, Conn., and
was received as a brother by Cook's father, Mr. John Cook,
and mother, Mrs. Elizabeth Cook. The two young men
spent a week together, and then Davis went to New York
to attend the meetings of the American Anti-Slavery Society.
He was a popular orator, and spoke before the members of Congress
on the subject of the Slave Trade, for a week or two, during the month
of March. The speech made great sensation among the
members of Congress, and was the cause of much discussion
in the country. Davis then returned to New Haven, where he
remained until the fall of 1796, when he again visited
Cook, and made his home with him for a time, and became
a member of the congregation of the First Congregational Church of
New Haven, and gave to the public a series of lectures on
the Slave Trade.
