LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into as of September 10, 1997, by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, an Illinois corporation ("BANK"), CMK DEVELOPMENT, L.L.C., a Michigan limited liability company ("BORROWER"), MID TOWN BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY 2017 AS TRUSTEE UNDER TRUST AGREEMENT DATED AUGUST 6, 1997 A/K/A TRUST NO. 2138 ("MORTGACOR") & COLIN M. KIHNKE ("GUARANTOR").

WHEREAS:

- 1. The BORROWER has heretofore executed a P omissory Note dated August 25, 1997 in the principal amount of \$120,000.00 of which the BANK is presently the Folder;
- 2. The NOTE is secured by a Mortgage, Assignment of Rene & Security Agreement (Chattel Mortgage) dated August 25, 1997 and recorded in the Recorder's Office & Cook County, Illinois, as document number 97693642 ("MORTGAGE"), conveying to BANK certain real estate described in Exhibit "A" attached hereto and by this reference incorporated herein ("REAL ESTATE");
- The NOTE is further secured by a Collateral Assignment of the Beneficial Interest in that certain land trust known as Mid Town Bank and Trust Company of Chicago a/t/u Trust Agreement dated August 6, 1997 a/k/a Trust No. 2138 ("ASSIGNMENT OF BENEFICIAL INTEREST"), which and trust holds title to the described REAL ESTATE;
- 4. The NOTE is further secured by a Commercial Guaranty ("GUARANTY") dated of even that therewith and executed by the GUARANTOR guaranteeing repayment of the indebtedness evidenced by said NOTE.
- 5. The BANK has disbursed to BORROWER the sum of \$120,000,00 which amount represents the entire principal sum of the indebtedness evidenced by the NOTE;
- 6. The interest rate evidenced on said NOTE is One (1) percentage point over the Prime Rate of interest,
- 7. The maturity date evidenced on said NOTE is February 25, 1998;
- 8. The BORROWER desires to amend the loan amount and maturity date as evidenced by the NOTE;

9. The BANK has agreed to such modification pursuant to the terms and conditions of a commitment of the BANK dated **September 10, 1997** ("COMMITMENT").

NOW THEREFORE, notwithstanding anything contained to the contrary in the NOTE, MORTGAGE, AND GUARANTY, and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

- A. The principal amount evidenced by the NOTE as of this date is \$350,000.00.
- B. The MORTGAGE modified hereby shall now secure:
 - all obligations incurred for the construction of certain improvements on the REAL ESTATE mongaged therein, including the acquisition cost of the land, and constitutes a "construction mortgage" within the meaning of Section 9-313(c) of the Illinois Uniform Commercial Code; and
 - all funds advanced pursuant to the COMMITMENT (which advances shall constitute part of the indebtedness secured hereby, whether more or less than the principal amount stated in the NOTE) and the due and punctual performance, observance and payment by BORROWER of all the terms, conditions, provisions and agreements provided in the COMMITMENT to be performed, observed or paid by BORROWER.
- C. The maturity date is hereby amended to **November 1, 1998**.
- D. Except as modified herein, the terms, coverants and conditions of the MORTGAGE AND GUARANTY shall remain unchanged and otherwise in full force and effect. In the even of any inconsistency between the terms of this agreement and the terms of the NOTE and/or MORTGAGE AND GUARANTY, the terms herein shall control.
- E. The lien of the MORTGAGE is hereby modified as security for the payment of the principal sum evidenced by the NOTE and amended by this MODIFICATION AGREFMENT.
- F. This agreement shall be governed by and construed under the laws of the State of Illinois.
