
## RELEASE OF MORTGAGE OF TRUST DEED



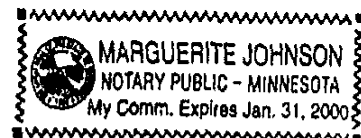
