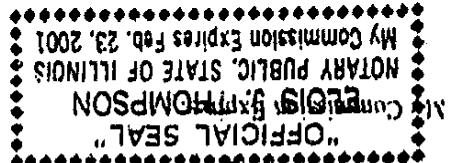

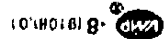

RIDER TO MORTGAGE BY AND BETWEEN AVANI SNEHAL MEHTA (THE "MORTGAGOR") AND
PREFERRED MORTGAGE (THE "LENDER").

The Mortgagor is executing simultaneously herewith that certain mortgage, dated DECEMBER 3, 1997 (the "Security Instrument") to secure a loan (the "Loan") made by PREFERRED MORTGAGE in the amount of \$ 35,600.00 to the Mortgagor, evidenced by a note (the "Note") of even date herewith. 2. Notwithstanding the provisions of Paragraph 6 of the Security Instrument, the Mortgagor agrees that the Lender or the Authority, as applicable, may, at any time and without prior notice, accelerate all payments due under the Security Instrument and Note, and exercise any other remedy allowed by law for breach of the Security Instrument or Note, if (a) the Mortgagor sells, rents or fails to occupy the property described in the Security Instrument as his or her permanent and primary residence; or (b) the statements made by the Mortgagor in the Affidavit of Buyer (Illinois Housing Development Authority Form MP-6A) are not true, complete and correct, or the Mortgagor fails to abide by the agreements contained in the Affidavit of Buyer; or (c) the Lender or the Authority finds any statement contained in that Affidavit to be untrue. The Mortgagor understands that the agreements and statements of fact contained in the Affidavit of Buyer are necessary conditions for the granting of the Loan.

3.
