PAYMENT REDUCTION NOTE RIDER

THIS PAYMENT REDUCTION NOTE RIDER ("Rider") is made this 10th day of December , 1997, and is incorporated into and shall be decimed to amend and supplement a Note in the amount of \$53,200.00 of even date herewith, executed by the undersigned ("Borrower") to TMS Mortgage Inc., dba The Money Store ("Lender")
secured by a Mortgage, Deed of Trust, Security Deed or Deed to Secure Debt ("Security Instrument") dated of even date herewith.
Any provisions of said Note, or other such instruments executed in connection with said indebtedness, which are inconsisten, with the provisions of this Rider, including, but not limited to, the amount of each monthly payment of principal and interest, are hereby amended or superseded to the extent necessary to conform such instruments to the provisions of this Rider.
If Borrower makes monthly payments one (1) through twelve (12) in full, on or before the payment due dates, and is not in default with respect to its other obligations to Lander. Lender will reduce the Note rate of the loan by .50% for the remaining term of the loan. Lender will also reduce the monthly payment, beginning with the thirteenth (13th) payment, to reflect the reduction of the interest rate.
2. If Borrower makes monthly payments thirteen (13) through twenty-four (24) in full, on or before the payment due dates, and is not in default with respect to its other obligations to Lender, Lender will reduce the Note rate of the loan then in effect by 30% for the remaining term of the loan. Lender will also reduce the monthly payment, beginning with the twenty-fifth (25th) payment, to reflect the reduction of the interest rate. This section shall apply even if Borrower did not qualify for the interest rate reduction under section I above.
If Borrower makes payments twenty-five (5) through thirty-six (36) in full, on or before the payment due dates, and is not in default with respect to its other obligations to Lender, Lender will reduce the Note rate of the loan then in effect by .50% for the remaining term of the .c.n. Lender will also reduce the monthly payment, beginning with the thirty-seventh (37th) payment, to reflect the reduction of the interest rate. This section shall apply even if Borrower did not qualify for the interest rate reduction under sections 1 and 2 above.
Lender will provide written notification to Borrower, after each twelve (12) month payment period referred to its Sections 1, 2, and 3 above, in the event the rate of interest payable of the Note will be reduced by .50%. Lender's records shall be the conclusive source of evidence of timeliness of Bernower's payments.

THIS ADJUSTABLE RATE RIDER is made this 10th day of December, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note (the "Note") to THS mortgage Inc., dbe The Money Store

(the "Lender") of the same rate and covering the property described in the Security Instrument and located at: 4201 South Albany Avenue, Chicago, IL 60632

THE NOTE CONTAINS PROVISIONS ALLOWING FOR CHANGES IN THE INTEREST RATE AND THE MONTHLY PAYMENT. THE NOTE LIMITS THE AMOUNT THE BORROWER'S INTEREST RATE CAN CHANGE AT ANY ONE TIME AND THE MINIMUM AND THE MAXIMUM RATE THE BORROWER MUST PAY.

ADDITIONAL COVENANTS. In addition to the governants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

INTEREST RATE AND MONTHLY PAYMENT CHANGES

The Note provides for an initial interest rate of rate and the monthly payments, as follows:

4. INTEREST RATE AND MONTHLY PAYMENT CHANGES

(A) Change Dates

The interest rate I will pay may change on the 1st day of July, 1939 and on the 1st day of every 5th month(s) thereafter. Each date on which my interest rate could change is called a "Change Date."

(B) The Index

Beginning with the first Change Date, my interest rate will be based on an Index. The "Index" is the average of interbank offered rates for 6 Month Libor U.S. dollar-denominated deposits in the London makes, based on quotations of major banks, as published by The Wall Street Journal. The most recent Index figure available as of the 20th day of the calendar month immediately preceding each Change Date is called the "Current Index."

If the index is no longer available, or is no longer published by The Wall Street Journal, the Note Holder will choose a new index or source of index that is based upon comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding Five and 1/2

percentage points (5.500 %) to the Current Index. The Note Holder will then round the result of this addition up to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the Maturity Date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

(D) Limits on Interest Rate Changes

The notice will include information required by law to be given me and also the title and temphone number of a person who will answer any question I may have regarding the notice.
