

MODIFICATION AGREEMENT

This agreement, made this the 4th day of December 1997, by and between the Mortgagee, LIBERTY FEDERAL BANK, FORMERLY KNOWN AS HINSDALE FEDERAL BANK FOR SAVINGS, party of the first part, owner of the mortgage hereinafter described, and the Mortgagor(s), TERESE E. LAROCCO, DIVORCED AND NOT SINCE REMARRIED, representing herself to be the owner(s) of the real estate hereinafter and in said mortgage described.

LOT 2 IN GALLAGHER AND HENRY'S ISHNALA SUBDIVISION UNIT #5, BEING A SUBDIVISION OF PART OF THE NE 1/4 OF SECTION 36, TOWNSHIP 37 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

WITNESSETH:

WHEREAS, the Mortgage(s) heretofore executed a certain mortgage dated JUNE 3, 1996 and recorded JUNE 11, 1996 in the recorder's office of COOK, County, Illinois as Document Number 96443303, conveying to LIBERTY FEDERAL BANK, FORMERLY KNOWN AS HINSDALE FEDERAL BANK FOR SAVINGS as Mortgagee certain premises in said mortgage particularly described and which said mortgage was given to secure the payment of one certain promissory note dated JUNE 3, 1996 in the amount of TWENTY-FIVE THOUSAND AND NO/100 (\$25,000.00).

AND KNOW THEREFORE, it is hereby agreed that said mortgage and supplement thereto, and any obligation or obligations secured thereby, be and the same are hereby modified, altered and amended in a manner so that TERESE E. LAROCCO, DIVORCED AND NOT SINCE REMARRIED, hereby agree to pay LIBERTY FEDERAL BANK, FORMERLY KNOWN AS HINSDALE FEDERAL BANK FOR SAVINGS, its successors and assigns, the amount remaining unpaid on said mortgage indebtedness in the sum of FORTY-FIVE THOUSAND FOUR AND NO/100 (\$45,000.00), with interest calculated on the outstanding balance at the rate of prime minus .50% as was stated in the original promissory note dated June 3, 1996. Payments are due on the 15th of every month until the whole of said indebtedness, including interest, shall have been paid except that if not sooner paid, the final payment of principal and interest shall be due and payable on the 15th DAY OF JUNE 2003.
