REVOLVING MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS

THIS REVOLVING MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTALS is made this 3rd day of November, 1997 by ROBERT HELLYER AND CYNTHIA SANTILLI (the "Mortgagor") to THE FIRST NATIONAL BANK OF CHICAGO (the "Mortgagee"), a national banking association, organized and existing under the laws of the United States of America, having its principal office at One First National Plaza, Cricago, Illinois 60670.

WITNESSETH

WHEREAS, the Mortgager is indebted to Mortgagee in the total principal sum of TWO HUNDRED TWENTY FOUR THOUSAND and 10/100 Dollars (\$224,000,00) or so much thereof as may be outstanding from time to time under a certain Multiple Advance Demand Note dated January 16, 1997 from Mortgagor payable to the order of Mortgagee in the principal amount of \$224,000,00 (said note and all modifications, renewals or extensions thereof, the "Note") plus interest in the amount as provided in and evidenced by the Note, which Note is incorporated herein by this reference. The Note has an adjustable rate and revolving feature.

NOW, THEREFORE, to secure (a) the payment of the indebtedness evidenced by the Note together with interest thereon (the "Indebtedness") and any fees in connection therewith, (b) the repayment of any advances or expenses of any kind incurred by Mortgagee pursuant to the provisions of or on account of the Note or this Mortgage, (c) the repayment of future advances, if any, disbursed by Mortgagee to Mortgagor in accordance with the terms of the Mortgage or the Note in excess of the principal of the indebtedness, and (d) the performance and observance of all of the terms, covenants, provisions and agreements or, this Mortgage, the Note and all other documents now or hereafter executed in connection with the Indebtedness (collectively, the "Loan Documents"), all of the foregoing not to exceed 300% of the principal amount of the Note, the Mortgagor agrees as follows:

ARTICLE I GRANT

1.01 The Mortgagor hereby grants, bargains, sells, releases, conveys, assigns, transfere, mortgages and confirms unto the Mortgagee, and grants a security interest in, the real estate described in hybrid A attached hereto and made a part hereof (the "Real Estate"), which with the property, estates and interests hereinafter described is referred to herein as the "Property";

Together with, all rents, issues, profits, royalties, income and other benefits derived from the Real Estate subject to the right, power and authority hereinafter given to Mortgagor to collect and apply such rents;

Together with, all leasehold estate, right, title and interest of Mortgagor in and to all leases or subleases covering the Real Estate or any portion thereof now or hereafter existing or entered into, and all right, title and interest of Mortgagor thereunder, including, without limitation, all cash or security deposits, advance rentals, and deposits or payments of similar mature;

Together with, all easements, rights-of-way and rights pertaining thereto or as a means of access thereto, and all tenements, hereditaments and appurtenances thereof and thereto;

Together with, any and all buildings and improvements now or hereafter erected thereon, including, but not limited to, the fixtures, attachments, appliances, equipment, machinery, and other articles attached to said buildings and improvements; and

Together with, all the estate, interest, right, title, other claim or demand, including claims or demands with respect to the proceeds of insurance, which Mortgagor now has or may hereinafter acquire in the Real Estate, and any and all awards made for the taking of eminent domain, or by any proceeding or purchase in flee thereof, of the whole or any part of the Real Estate, including without limitation any awards resulting from a change of grade of streets and awards for severance damages.

To have and hold the Property unto the Mortgagee, and its successors and assigns forever, for the uses and purposes herein set forth.

ARTICLE II REPRESENTATIONS

- 2.01 Mortgagor represents it has good and marketable title to the Property. Mortgagor represents that it has good right at d full power to sell and convey the same and that it has duly executed and delivered this Mortgage pursuance to proper directions and that Mortgagor will make any further assurances of title that the Mortgagee may require and will defend the Property against all claims and demands whatsoever.
- 2.02 Morigagor represents that the proceeds of the loan evidenced by the Note will be used for the purposes specified in Paragraph 6404 of Chapter 17 of the Illinois Revised Statutes and that the principal sum evidenced by the Note constitutes a Losiness loan which comes within the purview of such paragraph.
- 2.03 Neither Mortgagor nor, to the best of Mortgagor's knowledge, any previous owner of the Property or any third party, has used, generated, stored or disposed of any Hazardous Substances on the Property. For the purposes of this representation and warranty, Pagardous Substances shall include, but shall not be limited to, any toxic or hazardous wastes, pollutants or substances, including, without limitation, asbestos, PCBs, petroleum products and by-products, substances defined or listed as hazardous substances or toxic substances or similarly identified in or pursuant to the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. à 9601 et seq., hazardor, materials identified in or pursuant to the Hazardous Materials Transportation Act, 49 U.S.C. à 1802 et seq., hazardous wastes identified in or pursuant to The Resource Conservation and Recovery Act, 42 U.S.C. à 6901 a seq., any chemical substance or mixture regulated under the Toxic Substance Control Act of 1976, as amended, 15 J.C. à 2601 et seq., any toxic pollutant under the Clean Water Act, as amended, 33 U.S.C. à 1251 et sea,, any hazardous air pollutant under the Clean Air Act, 42 U.S.C. à 7401 et seq., and any hazardous or toxic substance or pollutant regulated under any other applicable federal, state or local environmental health or safety laws, regulations of roles of common law. Mortgagor shall indemnify and hold Mortgagee harmless from and against all liability, including all foresecable and unforesecable consequential damages, directly or indirectly arising out of the use, generation, acrage or disposal of Hazardous Substances, including without limitation, the cost of any required or necessary regain, clean-up or detoxification and the preparation of any closure or other required plans, whether such action is required or necessary prior to or following transfer of title to the Property, to the full extent that such action is attributable directly or indirectly, to the use, generation, storage or disposal of Hazardous Substances on the Property.

ARTICLE III WAIVER OF REDEMPTION

3.01 Mortgagor acknowledges that the Real Estate does not constitute agricultural real estate as said term is defined in Section 15-1201 of the Illinois Mortgage Foreclosure Law (the "Act") or residential real estate as defined in Section 15-1219 of the Act. Mortgagor hereby waives any and all rights of redemption under judgment of foreclosure of this Mortgage on behalf of Mortgagor, and on behalf of each and every person acquiring any interest in or title to the Real Estate or of any nature whatsoever subsequent to the date of this Mortgage. The foregoing waiver of right of redemption is made pursuant to the provisions of Section 15-160(B) of the Act. To the fullest extent permitted under applicable faw, Mortgagor shall not, and will not, apply for or avail itself of any appraisement, valuation, stay, extension or exemption law, or so-called "Moratorium Laws," now existing or hereafter enacted, in order to prevent or hinder the enforcement or foreclosure of this Mortgage, but hereby waives the benefit of such laws. Mortgagor for itself and all who may claim through or under it waives any and all right to have the Real Estate, and any estates comprising the Real Estate, marshalled upon any foreclosure of the lien hereof and agrees that any court having jurisdiction to foreclose such lien may order the Real Estate sold as an entirety.

ARTICLE IV MORTGAGOR'S COVENANTS

- 4.01 Mortgagor covenants and agrees to pay the Indebtedness and the other sums secured hereby in the manner and at the times provided for in the Loan Documents.
 - 4.02 Mortgagor covenants and agrees to pay, or cause to be paid, when due and payable by Mortgagor:
 - (a) all real estate taxes, personal property taxes, assessments, license fees, water and sewer rates and charges, and all other governmental levies and charges, of every kind and nature whatsoever, general and special, ordinary and extraordinary, unforescen as well as forescen, which shall be assessed, levied, confirmed, imposed or become a lien upon or against the Property or any portion thereof, and all taxes, assessments and charges upon the rents, issues, income or profits of the Property, or which shall become payable with respect thereto or with respect to the occupancy, use or possession of the Property, whether such takes, assessments or charges are levied directly or indirectly (hereinafter collectively called the "Taxes"); and
 - (a) all other payments or charges required to be paid to comply with the terms and provisions of this Mortgage.

Within ten (10) days after written demand therefor, Mortgagor shall deliver to Mortgagee the original, or a photostatic copy, of the official receipt evidencing payment of Taxes or other proof of payment satisfactory to Mortgagee. Failure of Mortgagor to deliver to Mortgagee said receipts or to submit other proof satisfactory to Mortgagee as aforesaid shall constitute ratiovent of Default hereunder.

- 4.03 To assure payment of Taxes and insurance premiums payable with respect to the Property as and when the same shall become due and payable:
 - (a) The Mortgagor shall deposit with into tgagee at the time of the disbursement of the proceeds of the Note:
 - (i) An amount equal to one-twelfth of such Taxes due multiplied by the number of months (plus one additional month) elapsed between the date on which the most recent installment for such taxes was required to be paid and the fails of such first deposit; and
 - (ii) An amount equal to one-twelfth of such an analynsurance premiums multiplied by the number of months (plus one additional month) elapsed between the date premiums on each policy were last paid to and the date of such first deposit.
 - (b) Concurrently with each monthly payment installment pursuant to the Note, Mortgagor shall deposit with Mortgagee an amount equal to nine (9%) percent of the last ascerta hable bills for Taxes and insurance premiums.
 - (c) The amount of such deposits ("Tax and Insurance Deposits") shall be based upon the most recently available bills therefor. All Tax and Insurance Deposits shall be held by the Morryague without any allowance of interest thereon.
 - (d) Monthly Tax and Insurance Deposits, together with monthly payments of principal, if any, and interest shall be paid in a single payment each month, to be applied to the following items in the following order:
 - (i) Tax and Insurance Deposits;
 - (ii) Indebtedness other than principal and interest on the Note;
 - (iii) Interest on the Note:
 - (iv) Amortization of the principal balances of the Note.

- (e) Mortgagee will pay insurance premiums and Taxes from the Tax and Insurance Deposits upon the presentation by Mortgagor of bills therefor, or upon presentation of receipted bills, reimburse Mortgagor for such payments. If the total Tax and insurance Deposits on hand are not sufficient to pay all of the Taxes and insurance premiums when due, Mortgagor will deposit with Mortgagee any amount necessary to make up the deficiency. If the total of such deposits exceeds the amount required to pay Taxes and insurance premiums, such excess shall be credited on subsequent deposits to be made for such items.
- (f) In the event of a default in any of the provisions of this Mortgage or the Note, Mortgagee may, but shall not be required to, apply Tax and Insurance Deposits on any Indebtedness, in such order and manner as Mortgagee may elect. When the indebtedness has been fully paid, any remaining Tax and Insurance Deposits shall be paid to Mortgagor. All Tax and Insurance Deposits are hereby pledged as additional security for the Indebtedness and shall not be subject to the direction or control of the Mortgagor.
- (g) Mortgagee shall not be liable for any failure to apply any amounts deposited to the payment of Taxes and insurance premiums unless while no default exists hereunder Mortgagor shall have presented to Mortgagee the appropriate Tax and insurance premium bills to be paid from the Tax and Insurance Gerbaits.
- 4.04 Mortgage, excenants and agrees to keep and maintain, or cause to be kept and maintained, the Property (including all improvements thereon and the sidewalks, sewers, and curbs) in good order and condition and will make or cause to be made, as and when the same shall become necessary, all structural and nonstructural, ordinary and extraordinary, foresee, and unforeseen repairs and all maintenance necessary to that end. Furthermore, and without limiting the generality of the foregoing, Mortgagor will suffer no waste. All repairs and maintenance required of Mortgagor shall be (in the reasonable opinion of Mortgagee) of first-class quality.
- 4.05 Mortgagor covenants and agrees that this Mortgage is and will be maintained as a valid mortgage lien on the Property and that Mortgagor will not, a rectly or indirectly, create or suffer or permit to be created, or to stand against the Property, or any portion thereof, or against the rents, issues and profits therefrom, any lien (including any Hens arising with respect to the payment of Taxes), security interest, encumbrance or charge whether prior to or subordinate to the lien of this Murty age unless written approval is first obtained from Mortgagee. Mortgagor will keep and maintain the Property free from all liens of persons supplying labor and materials for the construction, modification, repair or maintenance of any building or site improvement whether on the Property or not.
- 4.06 Mortgagor covenants and agrees, so long as the Indebtedress remains outstanding, to comply with all regulations, rules, ordinances, statutes, orders and decrees of any governmental authority or court applicable to the Mortgagor or applicable to the Property or any part thereof and will professly cure any violation of law and comply with any order of any such governmental authority or court in respect of the repair, replacement or condition of the Property and any governmental regulations concerning environmental control and improvements.
- 4.07 Mortgagor covenants and agrees that all awards heretofore or hereafter made by any public or quasi-public authority to the present and all subsequent owners of the Property by virtue of a exercise of the right of eminent domain by such authority, including any award for a taking of title, possession veright of access to a public way, or for any change of grade of streets affecting the Property, are hereby a signed to the Mortgagee.
- 4.08 Mortgagor covenants and agrees that neither the value of the Property nor the lien of this Mortgage will be diminished or impaired in any way by any act or omission of the Mortgagor, and the Mortgagor agrees it will not do or permit to be done to, in, upon or about said Property, or any part thereof, anything that may in any wise impair the value thereof, or weaken, diminish, or impair the security of this Mortgage.
- 4.05 Mortgagor covenants and agrees that if any action or proceeding is commenced in which Mortgagee in good faith deems it necessary to defend or uphold the validity, enforceability or priority of the lien and interest of this Mortgage or to preserve the value of the security for this Mortgage, all sums paid by Mortgagee for the expense of any such litigation to prosecute or defend the rights, lien and security interest created by this Mortgage (including reasonable attorneys' fees) shall be paid by Mortgagor, together with interest thereon at the rate then applicable under the Note and any such sums and the interest thereon shall be a lien and security interest on the Property prior to any right or title to, interest in or claim upon the Property attaching or accruing subsequent to the lien and security interest of this Mortgage, and shall be secured by this Mortgage.

- 4.10 Mortgagor covenants to furnish from time to time within lifteen (15) days after Mortgagee's request, a written statement, duly acknowledged, of the amount due upon this Mortgage, whether any alleged offsets or defenses exist against the Indebtedness and whether any defaults exist under the Loan Documents.
- 4.11 Mortgagor covenants and agrees that he will keep and maintain books and records of account, or cause books and records of account to be kept and maintained in which full, true and correct entries shall be made of all dealings and transactions relative to the Property, which books and records of account shall, at reasonable times and on reasonable notice, be open to the inspection of Mortgagee and its accountants and other duly authorized representatives. Such books of record and account shall be kept and maintained either:
 - (a) in accordance with generally accepted accounting practices consistently applied; or
 - (b) in accordance with a cash basis or other recognized comprehensive basis of accounting consistently applied.

Mortgager covenants and agrees to furnish to Mortgagee a report satisfactory to Mortgagee, including a balance sheet and supporting schedules and containing a detailed statement of income and expenses on the Property. Mortgager also covenants and agrees to furnish or cause to be furnished annually to Mortgagee an updated personal financial statement. Mortgagor shall certify that each such report presents fairly Mortgagor's financial position. Mortgagor further covenants and agrees to furnish, or cause to be furnished, to Mortgagee annually on or before April 10th of each year (or on or before August 30th of any year in which Mortgagor has elected an extension) copies of his federal income tax fillings for the previous year.

If Mortgagor omits to prepare and deliver promptly any report required by this paragraph, Mortgagee may elect, in addition to exercising any remedy for an event of default as provided for in this Mortgage, to make an audit of all books and records of Mo (grgor including his bank accounts which in any way pertain to the Property and to prepare the statement or statements which Mortgagor failed to procure and deliver. Such audit shall be made and such statement or statements shall be prepared by an independent Certified Public Accountant to be selected by Mortgagee. Mortgagor shall pay all expenses of the audit and other services, which expenses shall be secured hereby as additional Indebtedness and shall be immediately due and payable with interest thereon at the rate of interest as set forth in the Note and shall be secured by this Mortgage.

ARTICLE Y TRANSPER OR MORTGAGE OF PROPERTY

5.01 Mortgagor will not, without the prior written consent of Nortgagee, further mortgage, grant a deed of trust, pledge or otherwise dispose of or further encumber, whether by operation of law or otherwise, any or all of its interest in the Property. Mortgagor will not, without the prior written consent of Mortgagee, sell, assign, or transfer the Property or any interest therein. Any sale, assignment, crassfer, mortgage, deed of trust, pledge, change or other disposition or encumbrance made in violation of the above provisions shall be null and void and of no force and effect and the making thereof shall constitute an Event of Delach hereunder.

ARTICLE VI PERFORMANCE OF MORTGAGOR'S OBLIGATIONS

6.01 Upon the occurrence of an Event of Default under this Mortgage, then, without in iting the generality of any other provision of this Mortgage, and without waiving or releasing Mortgagor from any of its obligations hereunder. Mortgagee shall have the right, but shall be under no obligation, to pay any Taxes or other payment, or any sums due under this Mortgage, and may perform any other act or take such action as may be appropriate to cause such other term, covenant, condition or obligation to be promptly performed or observed on behalf of Mortgagor. In any such event, Mortgagee and any person designated by Mortgagee shall have, and is hereby granted, the right to enter upon the Property at any time and from time to time for the purposes of performing any such act or taking any such action, and all moneys expended by Mortgagee in connection with making such payment or performing such act (including, but not limited to, legal expenses and disbursements), together with interest thereon at the default rate set forth in the Note from the date of each such expenditure, shall be paid by Mortgagor to Mortgagee within ten (10) days after written notice to Mortgagor demanding such payment, and shall be secured by this Mortgage, and Mortgagee shall have same rights and remedies in the event of nonpayment of any such same by Mortgagor as in the case of a default by Mortgagor in the payment of the indebtedness. Nothing in this Section or in any other part of this Mortgage shall be construed to require Mortgagee to make any payment or perform any obligation of Mortgagor or any of them. Any action taken by

Mortgagee hereunder or in relation to the Property is for the sole benefit of Mortgagee and no other person shall rely upon any action, inaction, inspection or other act of Mortgagee in dealing with the Property or Mortgagor. Mortgagee in making any payment hereby authorized (a) relating to taxes and assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof, or (b) for the purchase, discharge, compromise or settlement of any other lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted.

ARTICLE VII ASSIGNMENT OF LEASES, RENTS AND CONTRACTS

- of the Property, as further security for the payment of the Indebtedness and other sums secured hereby. Mortgagor grants to Mortgagee the right to enter the Property and to let the Property, or any part thereof, and to apply said rents, issues, profits and proceeds after payment of all charges and expenses, on account of the Indebtedness and other sums secured hereby. This assignment and grant shall continue in effect until the Indebtedness and other sums secured hereby are paid in full. Mortgagee hereby agrees not to exercise the right to enter the Property for the purpose of robeting said rents, issues or profits, and Mortgagor shall be entitled to collect and receive said rents, issues, profits and proceeds, until the earlier of (x) the occurrence of an Event of Default hereunder or (y) written revocation of each right by the Mortgagee; provided, that any rents, issues and profits collected and received by Mortgagor where the occurrence of an Event of Default hereunder which is not cured within the applicable grace period provided hereby shall be deemed collected and received by Mortgagor in trust for Mortgagee and Mortgagor shall account to Mortgagee for the full amount of such receipts. Mortgagor agrees to apply said rents, issues and profits whenever received, to payment of the Indebtedness, all Taxes on or against the Property and other sams secured nereby.
- 7.02 The assignment contained in this Article VII is given as collateral security and the execution and delivery hereof shall not in any way import or diminish the obligations of the Mortgagor, nor shall this assignment impose any obligation on Mortgagor to perform any provision of any contract pertaining to the Property or any responsibility for the non-performance thereof by Mortgagor or any other person. The assignment under this Article VII is given as a primary pledge and assignment of the rights described herein and such assignment shall not be deemed secondary to the security interest and Mortgago of Mortgagor in the Property. Mortgagoe shall have the right to exercise any rights under this Article VII before, together with, or after exercising any other rights under this Mortgage.
- 7.03 Mortgager shall observe and perform all covenants conditions and agreements in each lease to which it is a party, now or hereafter affecting any portion of the Property. Mortgager shall not, without the prior written consent of Mortgagee, (a) accept any installments of rent for more than one month in advance or any security deposit for more than an amount equal to two months' rent, or (b) take any action or fail to take any action or exercise any right or option which would permit the tenant under any tense to cancel or terminate such lease, or (c) amend or modify any lease in a manner which would (i) decrease the rent payable per unit of time under the lease, (ii) decrease the payments to be made by the tenant under the lease for rent, taxes, insurance or other expenses, (lii) decrease the term of the lease, (iv) impose any additional obligations on the landford under the lease, or (v) consent to a sublease or a substitution of tenants under the lease. Mortgagor a rees that hereafter it shall not assign any of the rents or profits of the Property.
- 7.04. Nothing herein contained shall be construed as constituting Mortgagee a mortgagee in possession in the absence of the taking of actual possession of the Property by Mortgagee pursuant to Article !\(\) hereof. In the exercise of the powers herein granted Mortgagee, no liability shall be asserted or enforced against Mortgagee, all such liability being expressly waived and released by Mortgagor.

ARTICLE VIII DEFAULT

- 8.01 The occurrence of any one or more of the following events shall constitute an event of default (each, an "Event of Default") under this Mortgage:
 - (a) Failure of Mortgagor to observe or perform any of the covenants or conditions by Mortgagor to be performed under the terms hereof.

- (b) Nonpayment of principal under the Note when due, or nonpayment of interest under the Note or of any other obligations under any of the Loan Documents within five days after the same becomes due.
- (e) The occurrence of a default by Mortgagor or any guarantor of any of the Indebtedness under any other Loan Document not remedied within any applicable cure period.
- (d) Any warranty or representation of Mortgagor knowingly made hereunder was inaccurate or misleading in any material respect when made.
- (e) Mortgagor or any guarantor of any of the Indebtedness shall file a voluntary petition in bankruptcy or shall be adjudicated a bankrupt or insolvent, or shall file any petition or answer seeking any reorganization, arrangement, composition, readjustment, liquidation, dissolution, or similar relief under the present or any future applicable federal, state or other statute or law, or shall seek or consent to or acquieste in the appointment of any trustee, receiver or liquidator of Mortgagor or any guarantor of any of the kace-edness, or of all or any substantial part of their respective properties or of the Property; of if within sixty (60) days after the commencement of any proceeding against Mortgagor or any guarantor of any of the logolitedness seeking any reorganization, arrangement, composition, readjustment, liquidation, dissolution, or similar relief under the present or any future federal bankruptcy act or any present or future applicable federal, thate or other statute or law, such proceeding shall not be dismissed; or if, within thirty (30) days after the appointment of any trustee, receiver or liquidator of the Mortgagor or any guarantor of any of the Indebtedness (without the consent or acquiescence of such party) or of all or any substantial part of their respective properties or of the Property, such appointment shall not have been vacated or stayed on appeal or otherwise; or if, widdat sixty (60) days after the expiration of any such stay, such appointment shall not have been vacated.
 - (1) Any individual guarantor of the indebtedness represented hereby shall die or any corporate guarantor shall fail to maintain its corporate existence.
- 8.02 If an Event of Default described in Section 8.01(e) shall occur which is not cured within any applicable grace period provided for, the entire Indebedness shall immediately become due and payable without any election or action on the part of Mortgagee. If any other Event of Default shall occur which is not cured within any applicable grace period provided for, Mortgagæ may, at its option, exercise any and all of the following remedies:
 - (a) Declare the unpaid portion of the Indebteaness to be immediately due and payable, without further notice or demand (each of which hereby is express'y wrived by Mortgagor), whereupon the same shall become immediately due and payable.
 - (b) Enter upon the Property and take possession thereof and of all books, records and accounts relating thereto.
 - (c) Appoint a receiver for the Property, or any part thereof, and of the net income, rents, issues and profits thereof, without regard to the sufficiency of the Property covered by this Mortgage or any other security, and without the showing of insolvency on the part of Mortgagor or fraud or mismanagement, and without the necessity of filing any judicial or other proceeding for appointment of a receiver.
 - (d) Hold, lease operate or otherwise use or permit the use of the Property, or any portion thereof, in such manner, for such time and upon such terms as Mortgagee may deem to be in its best interest (making such repairs, alterations, additions and improvements thereto, from time to time, as Mortgagee shall deem necessary or desirable) and collect and retain all earnings, rentals, profits or other amounts payable in connection therewith.
 - (e) Sell the Property, in whole or in part:
 - (i) under the judgment or decree of a court of competent jurisdiction, or
 - (ii) sell any of the Collateral (as defined in Article XIII), in whole or on part, at public auction (if permitted by law) in such manner, at such time and upon such terms as Mortgagee may

- (f) Foreclose this Mortgage.

The defivery to Mortgagee of any policy or policies of insurance hereunder, or renewals thereof, shall constitute an assignment to Mortgagee of all unearned premiums thereon as further security for the payment of the indebtedness scarred hereby. In the event any foreclosure action or other proceeding hereunder is instituted by Mortgagee, all right, title and interest of Mortgagor or Beneficiary in any or to any policy or policies of insurance then in feare shall vest in Mortgagee.
- (b) Mortgagor shall obtain and keep in force during the term of this Mortgage public liability insurance, flood insurance, if applicable, and such other types of insurance in such amounts and in such form as Mortgagee shall require. Such insurance shall name Mortgagee as a co-insured and shall provide that it may not be cancelled or materially modified except after 30 days' prior written notice to Mortgagee. Mortgager shall deliver evidence of such insurance to Mortgagee in such form and at such times as Mortgagee may reasonably require.
- 12.02 (a) In case of damage to or the destruction of the improvements on the Property by fire or other casualty, Mortgagor, at Mortgagor's election exercised within thirty (30) days after the occurrence of loss or casualty, may (provided no Event of Default has occurred) cause all proceeds of insurance to be applied to the Indebtedness or the restoration to their former condition of the improvements damaged or destroyed; provided, that Mortgagor's right to elect to have the proceeds applied to restoration of the improvements shall be conditioned upon the Mortgagor's presenting to Mortgagee concurrently with notice of Mortgagor's election, evidence reasonably satisfactory to Mortgagor that (i) the proceeds of insurance are sufficient to repair or restore improvements, or, if such proceeds are insufficient, that Mortgagor has deposited with Mortgagor can complete such repairs or restoration prior to the date when the Note becomes due and payable. In the event Mortgagor does not or is not entitled to make the election aforesaid, Mortgagee may decide whether the insurance proceeds shall be applied against the debt secured hereby or in the repair or restoration of the improvements.

- (b) In the event the insurance proceeds are to be applied to the Indebtedness, Mortgagee may collect all proceeds of insurance after deduction of all reasonable expense of collection and settlement, including attorneys' and adjustors' fees and charges, and apply same against the Indebtedness.
