LOAN EXTENSION AGREEMENT

E. The extended maturity date of the Note is March 15, 1997. The parties desire to further extend said maturity date to May 15, 1997.


WHEREFORE, it is agreed as follows:


1. The due date of the Note is hereby extended to May 15, 1997.


2. Except as modified in paragraph 1 above, the Note and Loan Documents remain in full force and effect according to their terms.


