SUBORDINATION OF MORTGAGE

THIS SUBORDIDATION AGREEMENT is effective as of this 19th day September, 1997, by and among AMERICAN DIATIONAL BANK AND TRUST COMPANY OF CHICAGO ("ANB" or "Senior Mortgagee"), JOHN K. CRANE, AS TRUSTEE UNDER THE JOHN K. CRANE LIVING TRUST AGREMENT DATED OCTOBER 31, 1977, ("Junior Mortgagee"), and CHICAGO TITLE AND TRUST COMPANY, NOT PERSONALLY BUT SOLELY AS TRUSTEE UNDER TRUST AGREEMENT DATED DECEMBER 1, 1993, AND KNOWN AS T TRUST NO. 14000042 ("Borrower" or "Mortgr.goi").

WHEREAS, Mortgagor is the owner of certain previous commonly known as 1611 North Sheffield, Chicago, Illinois, in the county of Cook, as more paracularly described in Exhibit "A" attached hereto, and the improvements to be situated thereon (coliecasely, the "Property");

WHEREAS, Junior Mortgagee made a loan to Mortgagor in the amount of THREE HUNDRED FORTY THOUSAND AND NO/100 DOLLARS (\$340,000.00) evidenced by a Memorandum of Contract recorded with the Cook County Recorder of Deeds on March 14, 1994, as Document No. 94229519;

NOW, THEREFORE, to induce ANB to grant credit to the Borrower pursuant to the Note and in consideration of the making of the loan pursuant thereto and for other valuable

consideration, receipt of which is hereby acknowledged, the undersigned Borrower and Junior Mortgagee do hereby agree as follows:

- 1. <u>Subordination.</u> Upon the recordation of the Senior Mortgage with the Recorder of Deeds, Cook County, notwithstanding that the Junior Mortgage has been filed prior to the Senior Mortgage, the Junior Mortgage is hereby agreed to be and shall continue to be subject and subordinate to the Senior Mortgage and to all renewals, modifications and amendments thereof and thereto.
- 2. <u>No Amendment.</u> The Junior Mortgagee, the Senior Mortgagee, and Mortgagor each agree not to amend or modify the Junior Mortgage or the Senior Mortgage without the prior written consent of the other parties hereto.
- 3. <u>Binding Effect; Choice of Law.</u> The terms, covenants and conditions hereof shall inure to the benefit of and be binding upon the parties hereto, and their respective heirs, executors, administrators, successors and assigns.
- 4. Governing Law. This Subordination Agreement shall be governed by the internal laws (and not the law of conficts) of the State of Illinois.
