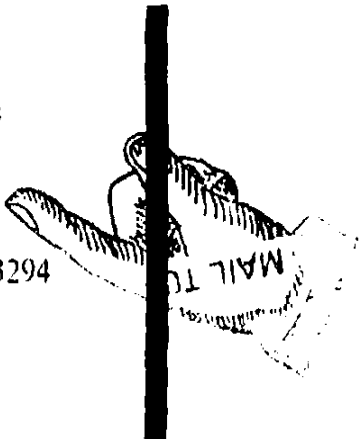

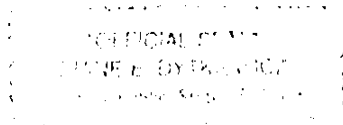

Re: Doc. #86 299 021

*Part of Lot 12 in Krenn and Dato's Crawford and East Prairie Road "L" Terminal Subdivision, being a Subdivision of the South 10 acres of the Northwest 1/4 of the Northwest 1/4 of Section 26, Township 41 North, Range 13 East of the Third Principal Meridian, described as follows:*

*Beginning at a point on the North line of said Lot, 50 feet Easterly from Northwest corner of said Lot; thence Easterly along North line of said Lot, 50 feet; thence Southerly to a point on the South line of said Lot 85.40 Feet Easterly from Southwest corner of said Lot; thence Westerly along South line of said Lot, 42.70 feet, thence Northerly to the place of beginning, in Cook County, Illinois.*
