### SUBORDINATION OF MORTGAGE

- 2. Such waiver and subordination of the lien of the Meadows Credit Union Mortgage to the Citibank, F.S.B. shall not in any other manner release or relinquish the lien of the Meadows Credit Union Mortgage upon the Property.
- 3. This Subordination of Mortgage shall be binding upon the successors and assigns of Meadows Credit Union.
