ITEM 9: A limited partner shall have the right to withdraw from the Partnership at any time after November 19, 2016. A withdrawn Limited Partner shall be entitled only to receive 50% of the fair market value of his limited partnership interest net of total liabilities, as determined under the partnership agreement as of the date of his withdrawal. Upon the dissolution and termination of the partnership, a Limited Partner shall be entitled to receive a distribution to the extent of his positive capital account balance.
