nave the immediate right to commence any legal action or proceeding calculated to evict and remove the Seller item-the premises.

Seller agrees to Warve all notices required by the Forcible Entry and Detainer Act or any other statute, and consents to an immediate judgment for possession. Seller further agrees to reimburse Buyer for all reasonable atternoys less and court costs Buyer may incur in the enforcement of his rights pursuant to this provision.

Seller shall deposit the sum of 3 in escrow with in escrower, at the time of closing, and any monies due the Buyer for Seller's uso and accupancy hereunder shall be paid to Buyer from this deposit and the balance, if any, shall be refunded to Seller. Possession shall be desired delivered to Buyer when Seller has vacated the premises and delivered the keys to the Buyer or the Escrower. Escrow money shall be limited to delivery of possession, and funds held pursuant to this paragraph shall be used only to satisfy payment for use and occupancy.

#### TITLE ÉVIDENCE:

Seiler, at his expense, shall lumish not less than live days prior to the closing date, a title commitment for an owners title insurance policy issued by an illinois idensed title insurance company in the amount of the purchase price covering the date hereof subject only to (a) the general exceptions contained in the title policy (except that, where the subject property qualifies as a single family residential unit, the policy shall provide extended coverage over the general exceptions); (b) the title exceptions set forth below; and (c) title exceptions pertaining to lions or encumbrances which have been assumed by the Buyer under the terms hereof or which the Seller has agreed to remove at closing from the proceeds hereunder. Any delay in delivery of the title commitment which is caused by the Buyer, fits agent, or his lending agency shall extend the time for delivery thereof by the Seller by such perior; of felay. If the title commitment discloses exceptions not provided for herein, the Seller shall have until closing to remove said exceptions or to acquire title insurance covering said unpermitted exceptions. If Seller fails to remove said exceptions or obtain additional insurance within the time state of herein, Buyer may elect to terminate this Contract and all monles paid by the Buyer shall be refunded to him.

#### DEED (CONVEYANCE, LIEVS, ENCUMBRANCES):

Seller shall convey or cause to be conveyed to Buyer title to the premises by a recordable general warranty deed with release of homestead rights, or trustee's deed if applicable, in burt tenancy, if more than one Buyer, or to Buyer's nominee, subject only to the following permitted exceptions, provided none of which shall recertably restrict the reasonable use of the premises as a residence: (a) general real estate taxes not due and payable at the time of closing; (b) building lines and building laws and ordinances, use or occupancy restrictions, conditions and coverants of record; (c) zoning laws and ordinances, which conform to the present usage of the premises; (d) public and utility essembles which serve the premises; (e) public roads and highways, if any; (f) party wall rights and agreements; if any; and (g) limitations and conditions imposed by the litinois Condominium Property Act and condominium declaration, if applicable.

#### PRORATIONS:

The following items, if applicable, shall be promised as of the date of a ming; (a) insurance premiums; (b) general real estate taxes, including special service areas, if any, (c) rents and security deposits; (d) interest on mortgage indeficulties assumed; (e) water taxes; (f) homeowners and/or condominium/ townhome association dues and assessments; (g) prepaid service contracts. Promitions of general taxes shall be on the basis of 105% of the last ascertainable bill. If said bill is based on a partial assessment or on an unimproved basis for improved property, a written agreement (with secrew) for final promition when the complete assessment information is available from the County Assessor shall be signed at closing by the parties hereto.

#### DAMAGE BY CASUALTY BEFORE CLOSING:

If the improvements on the property shall be destroyed or materially damaged by ilro or other casualty prior to closing, the provisions of the Uniform Vendor and Purchaser Risk Act of Illinois shall apply.

#### SURVEY

Seller at his expense, except for condominiums, shall lurnish to Buyer a current spotted survey (1/2) of not more than 6 months prior to the closing date) under certification by an illinois licensed land surveyor showing the location of all improvements, easements and building lines. The location of all improvements on the subject property shall be within the lot lines and not encrosed upon any easements or building lines, and said survey shall show no encroachments from adjoining properties. In the event said survey discloses encroachments, these encroachments shall be insured by the title company for Buyer and Buyer's lender at Seller's expense.

#### RESIDENTIAL REAL PROPERTY DISCLOSURE ACTI

This Contract is subject to the provisions of Public Act 89-111 known as the Residential Real Property Disclosure Act, tree terms of which are expressly incorporated herein and made a part of this Contract. The Seller represents that the information contained in an disclosure document is accurate as of the Contract Date.

#### LAND TRUST BENEFICIARY:

#### COMMISSION:

IN THE ABSENCE OF WRITTEN NOTICE WITHIN THE TIME SPECIFIED HEREIN, THIS PROVISION SHALL BE DEEMED WAIVED BY ALL PARTIES HERETO AND THIS CONTRACT SHALL CONTINUE IN FULL FORCE AND EFFECT.

Burner shall have the right, for a period of five (5) business days following the date of acceptance of this Contract, to have the subject property and its improvements inspected by a certified home inspection service of Buyer's choice, and at Buyer's cost.

If the condition report reveals any structural, heating, cooling, plumbing, mechanical or electrical delect(s) for which the cumulative , Buyer shall then have the right and option to make written request of Seller for cost of repair shall exceed 5 cenain repairs, said request to be provided to Seller, Seller's listing agent or attorney within the aforementioned five (5) business days. The Seller shall then have the following cotions of:

- making the repairs as requested by Buyer, or
- negotiating the cost of correcting said defects with Buyer, or
- declaring this Contract null and void.

In the event the Seller does not exercise any of those options and, in the further event that the Buyer does not waive said delects, the Buyer shall have the right to declare this Contract pull and void. Should either party to this Contract make such a declaration, any parnest more; of posit made by the Buyor shall be refunded in full. Seller's options must be exercised within five (5) husiness days of Seller's receipt of the Inspection report.

In the event Buye, makes a request for certain repairs, Buyer shall immediately deliver a copy of the inspection report to Seller.

The parties perate agree that the following items are accepted by Buyer "As is," shall not be made a part of Buyer "request for ropairs, and shall not be further negotiated:\_\_\_

In the absence of written notice of request for repairs from buyer within the time specified Herein. THIS HOME INSPECTION CONTINGENCY SHALL BE DEEMED WAIVED BY THE BUYER AND NO LONGER A PART OF THIS REAL ESTATE CONTRACT.

#### WELL AND SEPTIC TEST: (Select one applicable option)

In the event Seller elects not to make the necessary repairs, then this Contract, at the option of Buyer, shall become null and vold, and all entrest in ney shall be refunded to Buyer.

#### FLOOD PLAIN:

Buyer shall have the option of declaring this Contract null and void within five (5) days of receipt of any written notice or disclosure, including the Residential Real Property Disclosure Report, that the property is located in a special flood plain, rezero area which requires the Buyor to obtgin flood insurance. This option shall not exist in the event such written notice or disclosure was provided in statement number three (3) of a Residential Real Property Disclosure Report executed by both Seller and Buyer prior to the Contract Date.

#### TRANSFER TAX STAMPS:

Seller shall pay for the State of illinois and county real estate transfer tax stamps. Any municipal transfer tax shall be paid by the party designated in the ordinance of the municipality imposing the tax. 97006902

#### CLEAN CONDITION:

Seller shall leave the premises in broom-clean condition. All personal property not to be conveyed to Buyer and all refuse shall be removed from the premises at Seller's expense by the possession date.

#### PERFORMANCE/DEFAULT:

The earnest money and this Contract shall be held by (Escrowed) for the benefit of the parties hereto, and applied to the purchase price at closing.

The imediation conference shall be scheduled at the offices of the American Arbitration Association in Chicago, Illinois.

- (a) Both Seller and Buyer agree to execute all documents and provide all information necessary to enable any lunder to issue a commitment for mortgage or trust deed and to close this sale.
- Seller represents that he has not received any notice from any governmental body of any ordinance, zoning or building code violation, condemnation proceeding, pending rezoning or special assessment proceedings affecting the property.
  - All notices herein required shall be in writing and served upon the parties at the addresses shown on this Contract or upon the attorney for such party.
