

ROGERS PARK COMMUNITY DEVELOPMENT CORPORATION

The Corporation is organized exclusively for charitable, educational or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1985, as amended from time to time (hereinafter referred to as the "Code"). By way of illustration and not by way of limitation, the Corporation's purposes include creating and preserving affordable housing in Chicago's Rogers Park Community; aiding individuals and families to obtain decent, safe and sanitary housing; preventing community deterioration; lessening the burden of lederal, state and local governments to provide housing and economic development opportunities; providing educational, training and economic development opportunities for residents of the Rogers Park Community; and networking with other nonte the Cooperation Clark's Office profit organizations to promote the aforementioned purposes.
