#### THE GOVENANTS. CONDITIONS AND PROVISIONS PREVIOUSLY REFERRED TO ARE:

- 1. Propies of Borrower Borrower represents and wereants that:
  - a. 7 Borrower owns the Property;
  - b. Borrower has the right to mortrage, grant, and convey the Property to Trustee; and
  - c. There are no claims or charges outstanding against the Property except any mortgages or trust deeds that are currently shown in the office where real estate records are filed for the County where the Property is located.

Borrower gives a general warranty of title to Trustee on behalf of the Holder of the Note. This means that Borrower will be fully responsible for any losses which Trustee on behalf of the Holder of the Note suffers because someone other than Borrower has some of the rights in the Property that Borrower represents and warrants to have. Borrower will defend ownership of the Property against any claims of such rights.

- 2. Rorrower's Promise to Pay The Agreement. Borrower promises to promptly pay all amounts due on the Agreement except as explained in paragraph 9.
- 3. Borrower's Promis, to Pay Charges and Assessments. Borrower promises to pay all present and future liens, taxes, assessments, utility bills, and other charges on the Property, including any amounts on any prior mortgage or trust deed, as they become due.
- 4. Borrower's Promise to Buy Valuard Insurance. Borrower promises to obtain a learnd insurance policy payable to Trustee for the benefit of the Holder of the Note, and which covers all buildings on the Property. The insurance must be astisfactory to the Holder of the Note or insurance must be in the amounts and for the peciods of time required by the Holder of the Note. Borrower will a tiffy the Holder of the Note promptly if there is any loss or damage to the Property. The Trustee or Holder of the Note may file a "Proof of Loss" form with the insurance company. Borrower directs the insurance company to pay all "proceeds" to Trustee by the benefit of the Holder of the Note. "Proceeds" are any money that the insurance company owes to the Borrower under the policy. Unless the Holder of the Note agrees in writing that the Proceeds can be used differently, the Proceeds will be applied to pay the amount Borrower owes the Holder of the Note.

If any Proceeds are used to reduce the amount which Borrowe; owes the Holder of the Note under the Agreement, Borrower will still have to make the regular payments under the Agreement until the entire amount Borrower owes is paid in full. If Trustee forecloses this Trust Deed on behalf of the Holder of the Note, anyone who buys the Property at the foreclosure sale will have all the rights under the insurance policy.

- 5. Borrower's Promise to Buy Flood Issurance. If the Land or any part of the Land is located in a designated official flood-hazard area, Borrower promises to buy flood insurance in the maximum amount available or the amount secured by this Trust Deed, whichever is less. Borrower agrees to direct that any money payable under the flood insurance will be paid to Trustee on behalf of the Holder of the Note, but Borrower will still have to make regular property under the Agreement until the entire amount Borrower owns is paid in full.
- 6. Morrower's Promise to Maintain and Repair the Property. Borrowers shall (a) promptly repair, restore and rebuild any buildings or improvements now or hereafter on the Property which may become damaged or be districted; (b) keep said Property in good condition and repair, without waste, and free from mechanic's or other liens or claims for her not expressly subordinated to the lien hereof; (c) pay when due any indebtedness which may be secured by a lien or charge on the Property superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to Holder of the Note, (d) complete within a reasonable time any building or buildings new or at any time in process of erection apon said Property; (e) comply with all requirements of law or municipal ordinances with respect to the Property and the use thereof; (f) make no material alterations in said Property except as required by law or municipal ordinance.
- 7. Trustee/Holder of the Note Right to Take Action to Protect the Property. If (1) Borrower does not keep Borrower's promises and agreements made in this Trust Deed, or (2) someone (Borrower or anyone else) begins a legal proceeding that may significantly affect Trustee's or the Holder of the Note's rights in the Property (such as, for example, a legal proceeding in bunkruptcy, or to condemn the Property), then Trustee or the Holder of the Note may do and pay for whatever is necessary to protect the value of the Property and the rights of Trustee or the Holder of the Note in the Property. Actions of the Trustee or the Holder of the Note in the Property. Actions of the Trustee or the Holder of the Note under this section may include, for example, paying any amount due under any prior mortgage or trust deed, appearing in court, paying reasonable attorneys' fees, and entering on the Property to make receive.

If Borrower fails to maintain insurance on the Property as required in paragraphs 4 or 5, the Trustee or the Holder of the Note may purchase insurance on the Property, without notice to Borrower and charge Borrower for the cost as provided in this Trust Deed. If the Trustee or the Holder of the Note purchases this insurance, it will have the right to select the agent. Any hazard insurance and/or flood insurance purchased by the Trustee or Holder of the Note on the Property may be limited to the amount due under the Agreement at the time the immunes is purchased, even if the Property is worth more. The Trustee or the Holder of the Note is not required to obtain the lowest cost insurance that might be available.

- 8. Rights of the Truces and Holder of the Note. Any failure or delay by the Trustee or the Holder of the Note in enforcing the rights evaluable to them in this Trust Deed or the law, will not cause the Trustee or Holder of the Note to give up those rights. The Trust of a Holder of the Note may exercise and enforce any of its rights until its rights under the Trust Deed and. Each right that this Tout Deed gives to the Trustee or the Holder of the Note is separate. The Trustee or Holder of the Note may enforce and exercise from one at a time or all at once.
- 9. Joint Borrowers. Each person for algor this Trust Doed is responsible for keeping all of the promises made by the Borrower. Trustee or Holder of the Nove say choose to enforce their rights against sayone signing the Trust Doed as an individual or against all of them. However, If someone signed this Trust Deed, but did not sign the Agreement, then that person will not be required to pay any amount at the fire Agreement, but will have signed only to give Trustee or Holder of the Note the rights that person has in the Property an air the terms of this Trust Deed.
- 10. Selling the Property. Horrower agrees not to sell or transfer all or any part of the Property, or any rights in the Property, including the sale or transfer of the beneficial ownership in the Property where Borrower is a Land Trust, without the written consent of the Holder of the Note. This includes sale of Contract for Deed
- 11. No Defaults Under Prior Mortgages. If there is sheady a mortgage of deed of trust against the Property, the Borrower promises that there will prover be a default under that mortgage or deed of crust.
- 12. Recenses for Notice of Default and Foreclosure. Borrower and Trustee, on other of the Holder of the Note request the holder of any mortgage, deed of trust or other encumbrance with a lien which has orderity over this Trust Deed to give Notice to Trustee, at Trustee's address set forth on page one of this Trust Deed, of any default under the superior encombrance and of any sale or other foreclosure action.
- 13. No Other Mortgages or Deed of Trust. Bostower agrees not to mortgage or encumber by A deed of trust all or any part of the Property or allow anyone else to have a lieu on the Property without the Holder of the No. written consent.
- 14. Trustee/Holder of the Note Remedies and Foreclosure. If Trustee or Holder of the Note required Bozzower to pu the entire outstanding balance under the Agreement in one payment (called "acceleration") and Borrower fails to make the payment when due, then Holder of the Note or Trustee may foreclose this Trust Dued as provided below. However, before accelerating, the Trustee or the Holder of the Note will send Borrower a written notice by certified mail which states:
  - a. The promise that Borrower falled to keep or the representation or warranty that Borrower breached;
  - b. The action Borrower must take to correct that failure:
  - c. The date, at least 30 days away, by which the failure must be corrected;

  d. That if Borrower doesn't correct the failure or the representation or warranty that Borrower bridged, Trustee or Holder of the Note will accelerate, and if Borrower doesn't pay, Trustee or another person may buy the Property at a foreclosure sale:
  - e. That Illinois law allows Borrower to reinstate the Trust Deed after acceleration; and
- f. That Borrower may being stift in court to argue that all promises were kept and to present any other defenses Borrower has to acceleration.

Trustee or Holder of the Note need not send the notice if the promise Borrower failed to keep consists of Borrower's sale or transfer of all or a part of the Property or any rights in the Property without the written consent of the Holder of the Note. Such appointment may be made either before or after sale, without notice, without regard to the Alleney or insolvency of the Borrower at the time of application for such receiver and without regard to the then value of the Projecty or whether the same shall be then occupied as a homestead or not and the Trustee becaused may be appointed as such acceiver. - 17. Hight of Inspection. Trustee or the Holder of the Note shall have the right to impact the Property at all reasonable times and access thereto shall be permitted for that purpose.
- 18. Trustee's Obligations. Trustee has no duty to examine the tife, location, existence, or or action of the Property, or to inquire into the validity of the signatures or the identity capacity, or authority of the signate. On the Agreement or the Trust Deed, nor shall Trustee be obligated to record this Trust Deed or to exercise any power here's given unless expressly obligated by the terms hereof, nor be liable for any acts or emissions hereunder, except in case of its o'en pross negligance or misconduct or that of the agents or employees of Trustee, and it may require indomnities satisfactory to it before sameting any power herein given.
- 19. Release. Trustee shall release this Trust Deed and the lien thereof by proper instrument upon presentation of satisfactory evidence that all indebtedness secured by this Trust Deed has been fully paid; and Trustee may execute and deliver a release hereof to and at the request of any person who shall either before or after maturity thereof, produce and exhibit to Trustee the Agraement, representing that all indebtedness hereby secured has been paid, which representation Trustee may accept as true without inquiry. Where a release is requested of a successor trustee, such successor trustee may accept as the genuine Agreement herein described any Agreement which beer an identification number purporting to be placed thereon by a prior trustee hereinder or which conform in substance with the description herein contained of the Agreement and which purport to be executed by the persons herein designated as the makers faceof; and where the release is requested of the original Trustee and it has never placed its identification number on the Agreement described herein, it may accept as the genuine Agreement herein described any agreement which may be presented and which conform in substance with the description herein combined of the Agreement and which purport to be executed by the persons herein designated as makers thereof.
