DISTRICT DIRECTOR'S DEED

WHEREAS, the District Director of Internal Revenue, Chicago, Illinois, pursuant to authority vested in him by Section 6331, Internal Revenue Code, did cause levy to be duly executed, and did cause the property hereinafter described to be seized for the nonpayment of delinquent United States internal revenue taxes due from Stephen Foley, 27270 W. 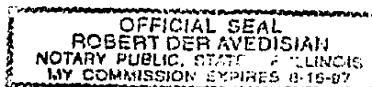
