TO HAVE AND TO HOLD the said premises with the uses and purposes herein and in said trust agreement set forth.

Full power and authority is hereby granted to said the said premises or any part thereof, to dedicate parks. TO HAVE AND TO HOLD the said premises with the appurtenances upon the trusts and for

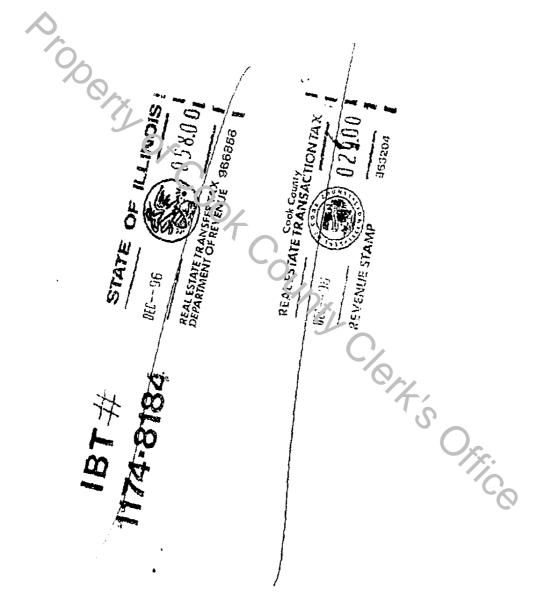
