AN ORDINANCE EXTENDING THE LIFE OF THE SPECIAL USE PERMIT GRANTED BY VILLAGE ORDINANCE NUMBER 92-4-Z-2238 AND EXTENDED BY VILLAGE ORDINANCE 93-10-Z-2339, WHICH GRANTED A SPECIAL USE PERMIT TO CONSTRUCT A 5 FOOT TO 6 FOOT BUILDING ADDITION AT THE EXISTING HOWARD JOHNSON HOTEL AT 9333 SKOKIE BOULEVARD, SKOKIE, ILLINOIS IN A B-3 BUSINESS DISTRICT

WHEREAS, ch April 20, 1992, the Mayor and Board of Trustees of the Village of Skokie adopted Village Ordinance Number 92-4-Z-2288 granting a Special Use Permit to construct a 5 foot to € foot building addition at the existing Howard Johnson Hotel at 9333 Skokie Boulevard, Skokie, Illinois, in a B-3 Business District; and

WHEREAS, the subject property is legally described as follows:
