Dear Mr. Crane:

You have been appointed trustee in the above Chapter 11 case. The duties of trustee are described in detail in 11 U.S.C. §1106, a copy of which is enclosed. I would like to emphasize certain requirements of that section:

1. Section 1106(a)(2) requires the trustee to file the list of creditors, schedules of assets and liabilities and statement of financial affairs required under §521(1) of the Code, if the debtor has not done so;
2. Section 1106(a)(3) requires the trustee to investigate the operations of the business and the desirability of the continuance of such business;
3. Section 1106(a)(5) requires the trustee to file a plan under §1121 of the Code, file a report why the trustee will not file a plan, or recommend conversion of the case to a case under Chapter 7 or Chapter 13 or dismissal of the case.

The trustee should operate the business in Chapter 11 only long enough to make a determination as to whether the business should be continued or whether the case should be converted or dismissed. If, in the opinion of the trustee, the business should be continued, he should file a plan or state why he will not do so forthwith.
