### MORTGAGE

THIS MORTGAGE IS DATED JANUARY 31, 1997, between Midwest Trust Services, Inc., Successor Trustee to Midwest Bank and Trust Company, whose address is 1606 N. Harism Avenue, Elmwood Park, IL 60707 (referred to below as "Grantor"); and Midwest Bank and Trust Company, whose address is 501 West North Avenue. GRANT OF MORTGAGE. RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter. Lender, at its option, may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate Indebtedness. Lender shall have the right at its option without notice to Grantor to declare the entire Indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to pay.
