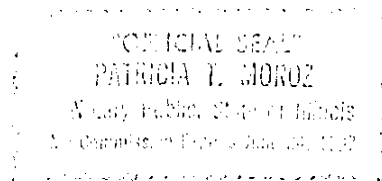

## EXHIBIT A

### LEGAL DESCRIPTION:

UNIT 301 IN LINCOLN LOFTS CONDOMINIUMS, AS DELINEATED ON THE SURVEY OF LOTS 3 THROUGH 13, INCLUSIVE, IN JOHN P. ### PARCEL 2:

EXCLUSIVE RIGHT TO USE OF PARKING SPACE 38, A LIMITED COMMON ELEMENT AS SET FORTH IN DECLARATION OF CONDOMINIUM AFORESAID.
