THIUS MODIFICATION OF MORTGAGE, SECURITY AGRICMENT AND FINANCING STATEMENT AND ASSIGNMENT OF RENTS AND LEASES

THIS THIRD MODIFICATION OF MORPJAGE, SECURITY AGREEMENT AND FINANCING STATEMENT AND ASSIGNMENT OF RENTS AND LEASES dated as of October 1, 1995 this "Modification"), is by BANK ONE, CHICAGO, M.A. f/k/a Bank One, Evanston, N.A.), a national banking association, as Trustee (the "Mortgagor") under a Trust Agreement dated June 2, 1978 and known as Trust No. R-2210 (the "Trust Agreement"), whose address is 300 Davis Street, Evanston, Illinois 60204, DENMIS E. BURGESS, an individual (the "Beneficiary"), whose address is c/o Humboldt Mfg. Co., 7300 West Agatite, Normidge, Illinois 60656, and LASALDE NATIONAL BANK, a national banking association (the "Mortgagee"), whose address is 135 South LaSalle Street, Chicago, Illinois 60603.

RECITALS:

A. The Mortgager executed and delivered to the Mortgagee that certain Mortgage, Security Agreement and Financing Statement dated as of October 30, 1992 and recorded on November 11, 1992 as Document No. 92-828221 in the Office of the Recorder of Deeds of Cook County, Illinois (the "Recorder's Office"), as amended by that certain First Modification dated as of September 1, 1993 and recorded on January 26, 1994 as Document No. 94082078 in the Recorder's Office, and by that certain Second Modification dated as of October 1, 1995 and recorded on December 20, 1175.

Document No. 95-884676 in the Recorder's Office (together, the "Mortgage"), which encumbers certain real property described in Exhibit A attached hereto and made a part hereof (the "Premises").

- B. The Mortgagor and the Beneficiary executed and delivered to the Mortgagee that certain Assignment of Rents and Leases dated as of October 30, 1992 and recorded on November 11, 1992 as Document No. 92-828222 in the Recorder's Office, as amended by the Modifications reterred to in Recital A hereof excepther, the "Assignment of Rents), which Assignment of Rents encumbers the Premises.
- C. The Mortgagee has made, and the Mortgage and the Assignment of Rents secure, a certain mortgage loan to the Mortgagor and the Beneficiary, as evidenced by that certain \$385,000 Note dated as of October 30, 1992 of the Mortgagor and the Deneficiary and payable to the order of the Mortgagee.

("RMC") evidenced by that certain \$2,600,000 Secured Revolving Note dated August 30, 1990, as amended, extended or replaced from time to time, as further amended by that certain \$2,600,000 Replacement Secured Revolving Note dated as of October 1, 1996 of HMC payable to the order of the Mortgagee, and (ii) a certain mortgage loan to HMC evidenced by that certain \$550,000 Secured Mortgage Note dated August 30, 1990, as amended, extended or replaced from time to time, as further amended by that certain \$697,488 Replacement Secured Mortgage Note dated as of September 1, 1993 of HMC payable to the order of the Mortgagee.
- E. The Premises are leased, in part, by the Beneficiary to HMC, and the Beneficiary will derive economic advantage from the aforementioned loans from the Mortgagee to HMC.
- F. The parties have agreed to amend the Mortgage and the Assignment of Rents as more particularly set forth herein.

NOW, THEREFORE, in consideration of the foregoing, the parties hereby agree as follows:

1. <u>RECITALS</u>. The foregoing recitals are hereby incorporated into and made a part of this Modification.

- 2. <u>DEFINITIONS</u>. Capitalized words and phrases not otherwise defined herein shall have the respective meanings assigned thereto in the Mortgage.
- 3. <u>OBLIGATIONS SECURED</u>. The Mortgage and the Assignment of Rents secures:
- (b) the obligations and liabilities of the Mortgagor and the Beneficiary to the Mortgagee evidenced by that certain \$385,000 Note dated as of October 30, 1992 of the Trustee and the Beneficiary payable to the order of the Mortgagee, as hereafter amended, extended or replaced from time to time ("Note A"); and
- evidenced by 100 that certain \$2,600,000 Secured Revolving Note dated August 30,0000, as amended, extended or replaced from time to time, as further anended by that certain \$2,600,000 Replacement Secured Revolving Note dated as of October 1, 1996 of HMC payable to the order of the Mortgagee, as hereafter amended, extended or replaced from time to time ("Note B"), and (ii) that certain \$550,000 Secured Mortgage Nore dated August 30, 1990, as amended, extended or replaced from time to time, as further amended by that certain \$697,486 Replacement Secured Mortgage Note dated as of September 1, 1993 of HMC payable to the order of the Mortgagee, as hereafter amended, extended or replaces from time to time ("Note 2").
- 4. NOTE. The term "Note" as defined in the Mortgage is hereby modified to refer, collectively, to Note A, Note B and Note C, and any and all extensions, renewals and modifications thereof and substitutions therefor, and all the obligations and liabilities of the Mortgagor, the Beneficiary and HMC to the Mortgagee set forth in Section 3 above.
- 5. <u>CONTINUING EFFECT</u>. All the terms of the Mortgage and the Assignment of Rents are hereby incorporated by reference herein, and the Mortgage and the Assignment of Rents, except as hereby modified, shall remain in full force and effect in all respects. The Mortgagor and the Beneficiary, by execution of this Modification, hereby reaffirm, assume and bind themselves to all of their respective obligations, duties, rights, covenants, terms and conditions that are contained in the Mortgage and the Assignment of Rents.
