- B. - 4. PAYMENTS. Mortgagor agrees that all payments under the Secured Debt will be paid when due and in accordance with the terms of the Secured Debt and this Securey Instrument.
- 5. PRIOR SECURITY INTERESTS. With regard a any other mortgage, deed of trust, security agreement or other limit document that created a prior security interest or encumbrance on the Property, Mortgagor agrees:
 - A. To make all payments when due and to perform of copply with all covenants.
 - B. To promptly deliver to Lender any notices that Mongagor tereives from the holder.

- 7. DUE ON SALE OR ENCUMBRANCE. - 11. LEASEHOLDS; CONDOMINIUMS; PLANNED UNIT DEVELOPMENTS. Mortgagor agrees to comply with the provisions of any lease if this Security Instrument is on a leasehold. - 13. REMEDIES ON DEFAULT. All remodies are distinct, cumulative and not exclusive, and the Lender is entitled to all remedies provided at law or equity, whether or not expressly set forth. The acceptance by Lender of any sum

By not exercising any remedy on Morigagor's default. Lender does not waive Lender's right to later consider the event a default if it continues or happens again.

- 14. EXPENSES: ADVANCES ON COVENANTS; ATTORNEYS' FEES; COLLECTION COSTS. Except when prohibited by law, Mortgagor agrees to pay all of Lender's expenses if Mortgagor breaches any covenant in this Security Instrument. Mortgagor will also pay on demand any amount incurred by Lender for insuring, inspecting, preserving or otherwise protecting the Property and Lender's security interest. Those expenses will bear interest from the date of the payment until raid in full at the highest interest rate in effect as provided in the terms of the Secured Debt. Mortgagor agrees to pay all costs and expenses incurred by Lender in collecting, enforcing or protecting Lender's rights and remedies under this Security Instrument. This amount may include, but is not limited to, atterneys' fees, court costs, and other legal expenses. This Security Instrument shall remain in effect until released. Lender agrees to pay any recordation costs of such release.
- 15. ENVIRONMENTAL LAW's AND HAZARDOUS SUBSTANCES. As used in this section, (i) Environmental Law means, without limitation, the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA, 42 U.S.C. 9601 et seq.), and all other initial, state and local laws, regulations, ordinances, court orders, attermey general opinions or interpretive letters concerning the public health, safety, welfare, environment or a hazardous substance; and (2) Hazardous Substance means any toxic, radioactive or hazardous material, waste, pollutant or contaminant which has characteristics which render the substance tangerous or potentially dangerous to the public health, safety, welfare or environment. The term includes, without limit fiel, any substances defined as "hazardous material," "toxic substances," "hazardous waste" or "hazardous substances" under any Environmental Law.

Mortgagor represents, warrants and agrees that:

- A. Except as previously disclosed and acknowledged in which to Lender, no Hazardous Substance is or will be located, stored or released on or in the Property. This restriction for a not apply to small quantities of Hazardous Substances that are generally recognized to be appropriate for the normal of and maintenance of the Property.

These rights may include, but are not limited to, any anti-deficiency or one-action laws.
