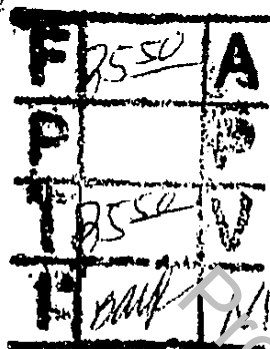

That part of Lot 7 in Block 1 in Calumet State Sibley Addition, being a subdivision of part of the Southeast Quarter of Section 9, Township 36 North, Range 14 East of the Third Principal Meridian, and part of the Southwest Quarter of Section 10, Township 36 North, Range 14 East of the Third Principal Meridian, lying north of the Little Calumet River, in Cook County, Illinois; described as follows:

Beginning at the intersection of the easterly right of way line of State Street with a point in the west line of said lot 7 distant south 9.906 meters [32.5 feet] from the northwest corner thereof; thence on an assumed bearing of North 44 degrees 28 minutes 42 seconds East along the southerly right of way line of Sibley Boulevard 8.551 meters [28.05 feet] to a point 6.096 meters [20 feet] east of the west line and 3.810 meters [12.5 feet] south of the north line of said lot 7; thence North 89 degrees 56 minutes 34 seconds East along said southerly right of way line parallel with the north line of said lot 7 a distance of 3.000 meters [9.84 feet]; thence South 41 degrees 27 minutes 22 seconds West 13.481 meters [44.23 feet] to the west line of said lot 7; thence North 00 degrees 56 minutes 42 seconds West along said west line 4.000 meters [13.12 feet] to the point of beginning.
