UNIFORM COVENANTS, Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. 11. Borrower Not Feliased; Forbearance By Lender Not a Waiver. 13. Loan Charges. (b) The Index. Beginning with the First Interest Rate Adjustment Date, my interest rate will be based on an Index. (e) Maximum and Minimum Rates. The interest rate I am required to pay during the term of this loan will not ever be greater than the Maximum Rate (even if the sum of the Current Index and Rate Differential is higher) nor less than the Minimum Rate leven if the sum of the Current Index and Rate Differential is lower), unless the property securing this loan is sold and the loan is assumed.
