NOW THEREFORE, in consideration of the premises and of the sum of ONE (1) DOLLAR to in hand paid, the said South Holland Trust & Savings Bank do hereby covenant and agree with the said, South Holland Trust and Savings, as Trustee, for the use and benefit of the legal holder of the note secured by said trust deed secondly herein described that the lien of the note owned by said South Holland Trust & Savings Bank and of the trust deed securing the same shall be and remain at all times a second lien upon the premises thereby conveyed subject to the lien of the trust deed to said South Holland Trust and Savings Bank as aforesaid for all advances made or to be made on the notes secured by said last named trust deed and for all other purposes specified therein.


