Related Documents. The words "Rusted Documents" mean and include without limitation all promissory notes, credit agreements, loan agreements, environmental agreements, guaranties, security agreements, mortgages, deeds of trast, and all other instruments, agreements and documents, whether now or hereafter existing, executed in connection with the Indebtudy iss.

Ranta. The word "Rents" means all rents, revenues moome, issues, profits and proceeds from the Property, whether due new or later, including without limitation and Rents from all leases described on any exhibit attached so this Assignment.

THIS ASSIGNMENT IS GIVEN TO SECURE (1) PAYMENT OF THE INDEPTEDNESS AND (2) PERFORMANCE OF ANY AND ALL OBLIGATIONS OF GRANTOR UNDER THE HOTE, THIS ASSIGNMENT, AND THE RELATED DOCUMENTS. THIS ASSIGNMENT IS GIVEN AND ACCEPTED ON THE FOLLOWING TERMS:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Assignment or any Related Document, Grantor shall pay to Lender all amounts secured by this Assignment as they become due, and shall strictly perform all of Grantor's obligations under this Assignment. Unless and until Lender exercises its right to collect the Rents as provided below and so long as there is no default under this Assignment, Grantor may remain in possession and courted of and operate and manage the Property and collect the Rents, provided that the granting of the right to collect the Rents shall not constitute Lender's consent to the use of casa collateral in a bankruptcy proceeding.

GRANTOR'S REPRESENTATIONS AND WARRANTIES WITH RESPECT TO THE RENTS. With respect to the Rents, Grantor represents and warrants to Lender that:

Oramorahis. Grantor is entitled to receive the Rents free and clear of all rights, loans, liens, encurabrances, and claims except as disclosed to and accepted by Lender in writing.

First to As ton. Gramor has the full right, power, and authority to enter into this Assignment and to assign and convey the kents to Lender.

No Prior Assignment. Grantor has not previously assigned or conveyed the Rents to any other person by any instrument now in force.

ello Fusther Transfer. Grantor will not sell, assign, encumber, or otherwise dispose of any of Grantor's rights rise the Rents except as provided in this Agreement.

LENGER'S RIGHT TO COLLECT RENTS. Lender shall have the right at any time, and even though no default shall have occurred under this Assignment, to collect and receive the Rents. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

Notice to Tenants. Lender may send notices to any and all tenants of the Property advising them of this Assignment and directing all Rents to be paid directly to Lender or Lender's agent.

Enter the Property. Lender may enter upon and take possession of the Property; demand, collect and receive from the tenants or from any other persons liable therefor, all of the Rents; institute and carry on all legal proceedings necessary for the protection of the Property, including such proceedings as may be necessary to recover possession of the Property; collect the Rents and remove any tenant or tenants or other persons from the Property.

Maintain the Property. Lender may enter upon the Property to maintain the Property and keep the same in

repair; to pay the costs thereof and of all services of all employees, including their equipment, and of all continuing costs and expenses of maintaining the Property in proper spair and condition, and also to pay all taxes, assessments and water utilities, and the premiums on tire and other insurance effected by Lender on the Property.

Compliance with Laws. Lender may do any and all things to execute and comply with the laws of the State of Illinois and also all other laws, rules, orders, ordinances and requirements of all other governmental agencies affecting the Property.

Lease the Property. Lender may rent or lease the whole or any part of the Property for such term or terms and on such conditions as Lender may deem appropriate.

Employ Agents. Lender may engage such agent or agents as Lender may deem appropriate, either in Lender's came or in Grantor's name, to rent acid manage the Property, including the collection and application of Rents.

FULL PERFORMANCE. If Grantor pays all of the indetectness when due and otherwise performs all the obligations imposed upon Grantor under this Assignment, the Nove, and the Related Documents. Lender shall execute and deliver to Grantor a suitable satisfaction of this Assignment and suitable statements of termination of any financing statement on file evidencing Lender's formy interest in the Rems and the Property Any termination for required by law shall be paid by Grantor, if provided by applicable law. Compliance Default. Failure of Grantor to comply with any other term, obligation, covenant or condition committed in this Assignment, the Note or in any of the Related Documents.

False Statements. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Assignment, the Note or the Related Documents is false or misleading in any waterial respect, either now or at the time made or furnished.

Defective CollateraSasstion. This Assignment or any of the Related Documents ceases to be in full force and effect (including failure of any collateral documents to create a valid and perfected security interest or lien) at any time and for any reason.

Citier Defaults. Failure of Gramor to comply with any term, obligation, covenant, or condition contained in any other agreement between Grantor and Lender.

Death or Insolvency. The dissolution or termination of Grantor's existence as a going business or the death

of any partner, the insolvency of Grantor, the appointment of a receiver for any part of Grantor's property, any assignment for the benefit of creditors, any type of creditor workout, or the commencement of any proceeding under any bankruptcy or insolvency laws by or against Grantor.

Foreclosuse, Forfeiture, etc. Commencement of foreclosure or forfeiture proceedings, whether by judicial proceeding, self-help, repossession or any other method, by any creditor of Grantor or by any governmental agency against any of the Property. However, this subsection shall not apply in the event of a good faith dispute by Grantor as to the validity or reasonableness of the claim which is the basis of the foreclosure or for a surety bond for the claim satisfactory to Lender.

Collect Rents. Lender shall have be right, without notice to Grantor, to take possession of the Property and collect the Rems, including amount, past due and ampaid, and apply the net proceeds, over and above Lender's costs, against the indebtedness. In furtherance of this right, Lender shall have all the rights provided for in the Lender's Right to Collect Section, above. If the Rems are collected by Lender, then Grantor irrevocably designates Lender as Grantor's interprey-in-fact to endorse instruments received in payment thereof in the name of Grantor and to negociate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's designate satisfy the obligations for which the payments are made, whether or not any proper grounds for the lemand existed. Lender may exercise its rights under this subparagraph either to person, by agent, or through a receiver.

Mortgages in Possession. Lender shall have the right to be placed as mortgages in possession or to have a receiver appointed to take possession of all or any part of roperty, with the power to protect and preserve the Property, to operate the Property preceding foreclosure of the roperty, and to collect the Rems from the Property and apply the stoceeds, over and above the cost of the roceivership, against the Indebtedness.
